## AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, 2 3 primary and election expenses and election contests; creating and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, 6 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 7 8 revising and consolidating the laws relating thereto; and 9 repealing certain acts and parts of acts relating to 10 elections," in the Secretary of the Commonwealth, further providing for explanation of ballot question. 11 12 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. Section 201.1 of the act of June 3, 1937 16 (P.L.1333, No.320), known as the Pennsylvania Election Code, is amended to read: 17 18 Section 201.1. Explanation of Ballot Question. -- (a) 19 Whenever a proposed constitutional amendment or other State-wide 20 ballot question shall be submitted to the electors of the 21 Commonwealth in referendum, the Attorney General shall prepare a statement in plain English which indicates the purpose, 22

23 limitations and effects of the ballot question on the people of

- 1 the Commonwealth. The Secretary of the Commonwealth shall
- 2 include such statement in his publication of a proposed
- 3 constitutional amendment as required by Article XI of the
- 4 Constitution of Pennsylvania. The Secretary of the Commonwealth
- 5 shall certify such statement to the county boards of elections
- 6 who shall publish such statement as a part of the notice of
- 7 elections required by section 1201 or any other provision of
- 8 this act. The county board of elections shall also require that
- 9 at least three copies of such statement be posted in or about
- 10 the voting room outside the enclosed space with the specimen
- 11 ballots and other instructions and notices of penalties. In
- 12 election questions which affect only one county or portion
- 13 thereof, the county board of elections shall fulfill these
- 14 requirements in the place of the Attorney General and the
- 15 Secretary of the Commonwealth.
- 16 (b) Each member of the General Assembly shall hold a public
- 17 <u>meeting within the member's respective legislative district for</u>
- 18 the purpose of receiving public comment on a proposed
- 19 constitutional amendment or other State-wide ballot question.
- 20 The public meeting shall:
- 21 (1) be held after the preparation of the statement of plain
- 22 English under subsection (a), but before the submission of the
- 23 proposed constitutional amendment or other State-wide ballot
- 24 guestion to the electors of the Commonwealth in referendum; and
- 25 (2) comply with 65 Pa.C.S. Ch. 7 (relating to open
- 26 meetings).
- 27 Section 2. This act shall take effect in 60 days.
