AN ACT

- 1 Providing for release of information by coroners and medical examiners.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Release of
- 7 Coroner and Medical Examiner Information Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "County." A county of this Commonwealth, including a county
- 13 within which is located a city of the first class or with which
- 14 a city of the first class is coextensive.
- 15 Section 3. Investigation information.
- 16 (a) General rule. -- Except as provided in subsection (b), the

- 1 following apply to public release of information by a coroner or
- 2 medical examiner:
- 3 (1) Following an investigation by a coroner or medical
- 4 examiner to determine the cause of any death in this
- 5 Commonwealth, the coroner or medical examiner shall not
- 6 release to the public the name of the deceased and the cause
- 7 and manner of death unless the release is in accordance with
- 8 the requirements under paragraph (2).
- 9 (2) Release of the information under paragraph (1) may
- 10 not occur until either notification of the next of kin of the
- deceased individual is confirmed or 72 hours have elapsed
- following the determination of the identity of the deceased
- 13 individual and the cause and manner of the death, whichever
- 14 occurs first.
- 15 (b) Exception. -- This section shall not apply in cases of a
- 16 public health emergency as determined by the coroner or medical
- 17 examiner.
- 18 Section 4. Applicability.
- 19 This act shall apply in each county of this Commonwealth.
- 20 Section 5. Effective date.
- 21 This act shall take effect in 60 days.
