AN ACT

1 2 3 4	Designating a bridge, identified as Bridge Key 45635, on that portion of S.R. 1036, also known as Rowena Drive, over Howells Run at Lake Rowena, Ebensburg Borough, Cambria County, as the Charles J. Vizzini Memorial Bridge.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Charles J. Vizzini Memorial Bridge.
8	(a) FindingsThe General Assembly finds and declares as
9	follows:
10	(1) Charles J. Vizzini was born March 8, 1924, to John
11	and Lillian Vizzini in Colver.
12	(2) He served in the United States Army during World War
13	II as a Private and was wounded twice.
14	(3) While fighting in France, Mr. Vizzini was struck in
15	the chest by bullets from a German automatic pistol and was
16	saved from serious injury and possible death by a Catholic
17	Bible in his left breast pocket and a Catholic missal in his
18	right breast pocket when bullets penetrated both books.
19	(4) After returning to Cambria County, Mr. Vizzini went

on to graduate from Cambria Rowe Business College and later
 worked for a time as a coal miner and steelworker, in this
 Commonwealth's Ebensburg Center and eventually at the
 Department of Auditor General for more than 25 years.

5 (5) A passionate advocate for his fellow veterans, Mr. 6 Vizzini served as Commander of Ebensburg Post 4963, Veterans 7 of Foreign Wars, and organized annual Veterans Day memorial 8 services as well as memorial services for the anniversary of 9 the bombing of Pearl Harbor and to honor the memory of fellow 10 Cambria County native Marine Sergeant Michael Strank, who 11 helped to raise the United States flag at Iwo Jima.

12 (6) A caring member of his community, Mr. Vizzini 13 organized memorial services to honor the 63 miners who died 14 in the 1940 Sonman Mines explosion in Portage and was 15 influential in honoring the 112 individuals who lost their 16 lives in the Cambria Steel Company's 1902 Rolling Mine Mill 17 explosion in Johnstown.

18 (7) Mr. Vizzini was well-known throughout his community, 19 most notably for his passionate advocacy for his fellow 20 veterans and for the residents of Cambria Township, 21 including, but not limited to, his efforts to keep this 22 Commonwealth's Ebensburg's Center open, his work with 23 Ebensburg's annual Christmas celebrations, particularly the 24 life-size nativity scene, his organization of the Northern 25 Cambria County Immigrants Day in Nanty Glo and his efforts to 26 clean Sandyvale Cemetery.

(8) Charles J. Vizzini passed away on August 11, 2009,
at the age of 85.

29 (9) A decorated military veteran, Mr. Vizzini's awards
30 include two Purple Hearts and one Bronze Star.

(b) Designation.--The bridge, identified as Bridge Key
45635, on that portion of S.R. 1036, also known as Rowena Drive,
over Howells Run at Lake Rowena, Ebensburg Borough, Cambria
County, is designated as the Charles J. Vizzini Memorial Bridge.
(c) Signs.--The Department of Transportation shall erect and
maintain appropriate signs displaying the name of the bridge to
traffic in both directions on the bridge.
