1 2 3	Amending Title 65 (Public Officers) of the Pennsylvania Consolidated Statutes, in ethics standards and financial disclosure, further providing for restricted activities.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Section 1103(j) of Title 65 of the Pennsylvania
7	Consolidated Statutes is amended to read:
8	§ 1103. Restricted activities.

10	(j) Voting conflict
11	(1) Where voting conflicts are not otherwise addressed
12	by the Constitution of Pennsylvania, by paragraph (2) or by
13	any law, rule, regulation, order or ordinance, the
14	[following] procedure prescribed in this paragraph shall be
15	employed. Any public official or public employee who in the
16	discharge of his official duties would be required to vote on
17	a matter that would result in a conflict of interest shall
18	abstain from voting and, prior to the vote being taken,

1 publicly announce and disclose the nature of his interest as 2 a public record in a written memorandum filed with the person 3 responsible for recording the minutes of the meeting at which the vote is taken, provided that whenever a governing body 4 5 would be unable to take any action on a matter before it 6 because the number of members of the body required to abstain 7 from voting under the provisions of this section makes the 8 majority or other legally required vote of approval 9 unattainable, then such members shall be permitted to vote if disclosures are made as otherwise provided herein. In the 10 case of a three-member governing body of a political 11 12 subdivision, where one member has abstained from voting as a 13 result of a conflict of interest and the remaining two 14 members of the governing body have cast opposing votes, the 15 member who has abstained shall be permitted to vote to break the tie vote if disclosure is made as otherwise provided 16 17 herein.

18 (2) Any public official or public employee who is a 19 member of a board of school directors and who in the 20 discharge of his official duties would be required to vote on a matter that would result in negotiating the terms and 21 22 conditions or approval of a collective bargaining agreement between the board of school directors and a collective 23 24 bargaining unit that represents a member of the immediate 25 family of the member of the board of school directors shall 26 abstain from voting and, prior to the vote being taken, 27 publicly announce and disclose the nature of his interest as 28 a public record in a written memorandum filed with the person 29 responsible for recording the minutes of the meeting at which 30 the vote is taken.
