AN ACT

1	Amending the act of June 3, 1937 (P.L.1333, No.320), entitled
2	"An act concerning elections, including general, municipal,
3	special and primary elections, the nomination of candidates,
4	primary and election expenses and election contests; creating
5	and defining membership of county boards of elections;
6	imposing duties upon the Secretary of the Commonwealth,
7	courts, county boards of elections, county commissioners;
8	imposing penalties for violation of the act, and codifying,
9	revising and consolidating the laws relating thereto; and
10	repealing certain acts and parts of acts relating to
11	elections," in penalties, providing for immunity from
12	liability for report of election misconduct.
13	The General Assembly of the Commonwealth of Pennsylvania
14	hereby enacts as follows:
15	Section 1. The act of June 3, 1937 (P.L.1333, No.320), known
16	as the Pennsylvania Election Code, is amended by adding a
17	section to read:
18	Section 1855. Immunity from Liability for Report of Election
19	<u>Misconduct(a) A person shall have immunity from civil and</u>
20	criminal liability that might otherwise result from any of the
21	<u>following:</u>
22	(1) Making a report in good faith of a suspected crime

1	relating in any manner to the conduct of an election.
2	(2) Confessing to committing or being an accessory to the
3	commission of a crime relating in any manner to the conduct of
4	an election.
5	(3) Cooperating or consulting with an investigation relating
6	in any manner to the conduct of an election.
7	(4) Testifying in a judicial or investigatory proceeding
8	relating in any manner to the conduct of an election.
9	(b) The Attorney General shall implement a program to pay a
10	reward of at least five thousand dollars (\$5,000) to a person
11	who makes a report under subsection (a)(1) leading to the arrest
12	and conviction of an offender for a crime relating in any manner
13	to the conduct of the election.
14	(c) The Secretary of the Commonwealth shall cause to be
15	printed on each absentee ballot and mail-in ballot a statement
16	<u>that a reward of at least five thousand dollars (\$5,000) is</u>
17	offered for a report of election fraud that leads to the arrest
18	and conviction of the offender.
