AN ACT

1	Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An
2	act relating to alcoholic liquors, alcohol and malt and
3	brewed beverages; amending, revising, consolidating and
4	changing the laws relating thereto; regulating and
5	restricting the manufacture, purchase, sale, possession,
6	consumption, importation, transportation, furnishing, holding
7	in bond, holding in storage, traffic in and use of alcoholic
8	liquors, alcohol and malt and brewed beverages and the
9	persons engaged or employed therein; defining the powers and
10	duties of the Pennsylvania Liquor Control Board; providing
11	for the establishment and operation of State liquor stores,
12	for the payment of certain license fees to the respective
13	municipalities and townships, for the abatement of certain
14	nuisances and, in certain cases, for search and seizure
15	without warrant; prescribing penalties and forfeitures;
16	providing for local option, and repealing existing laws," in
17	Pennsylvania Liquor Control Board, providing for self-
18	exclusion.
19	The General Assembly of the Commonwealth of Pennsylvania
20	hereby enacts as follows:
21	Section 1. The act of April 12, 1951 (P.L.90, No.21), known
22	as the Liquor Code, is amended by adding a section to read:
23	Section 218. Self-Exclusion(a) The board shall provide
24	by regulation for the establishment of a list of individuals
25	self-excluded from purchasing alcohol in this Commonwealth. Any

1	individual may request placement on the list of self-excluded
2	individuals by acknowledging in a manner to be established by
3	the board. A request for self-exclusion shall contain the
4	following information of the individual:
5	(1) Name, including any aliases or nicknames.
6	(2) Date of birth.
7	(3) Address of current residence.
8	(4) Telephone number.
9	(5) Social Security number, when voluntarily provided.
10	(6) Physical description, including height, weight, gender,
11	hair color, eye color and any other physical characteristic that
12	<u>may assist in identification.</u>
13	(7) Government-issued photo identification.
14	(b) The board shall maintain the self-exclusion list under
15	subsection (a). A period of self-exclusion shall remain in
16	effect for a period of five years or until the individual
17	requesting self-exclusion voluntarily requests for the board to
18	remove the individual from the self-exclusion list. An
19	individual may renew their self-exclusion at any time. No
20	individual may place another individual on the self-exclusion
21	list maintained by the board. A court may not consider the self-
22	exclusion list under this section in any proceeding before the
23	court nor may a court order any individual to be added to the
24	self-exclusion list under this section.
25	(c) No licensed entity under this act or employe thereof may
26	be liable to any self-excluded person or to any other party in
27	any judicial proceeding for any harm, monetary or otherwise,
28	which may arise as a result of:
29	(1) the failure of a licensed entity or employe thereof to
30	withhold alcohol from or restore any privileges to a self-

1 <u>excluded person; or</u>

2	(2) otherwise permitting or not permitting a self-excluded
3	individual to engage in prohibited activity in the facility or
4	participate in prohibited activity while on the list of self-
5	<u>excluded persons.</u>
6	(d) Notwithstanding any other law to the contrary, the
7	board's list of self-excluded persons shall not be open to
8	public inspection. Nothing in this section, however, shall be
9	construed to prohibit an entity licensed under this act from
10	disclosing the identity of individuals self-excluded under this
11	section to affiliated entities in this Commonwealth or other
12	jurisdictions for the limited purpose of assisting in the proper
13	administration of this act operated by affiliated licensed
14	entities under this act.

15 Section 2. This act shall take effect in 60 days.
