AN ACT

- Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying and enumerating certain subjects of taxation and imposing taxes thereon; providing procedures for the payment, collection, administration and enforcement thereof; providing 5 for tax credits in certain cases; conferring powers and 6 imposing duties upon the Department of Revenue, certain employers, fiduciaries, individuals, persons, corporations and other entities; prescribing crimes, offenses and 9 penalties," in personal income tax, further providing for 10 classes of income relating to employee stock ownership plans. 11 12 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 13 14 Section 1.
