AN ACT

- 1 Establishing the Pollinator Task Force and providing for its
- powers and duties; and imposing duties on the Department of
- 3 Agriculture.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Pollinator
- 8 Task Force Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Department." The Department of Agriculture of the
- 14 Commonwealth.
- 15 "Pollinator." A beneficial insect, domestic or wild, which
- 16 is effective at pollinating plants during its life cycle.
- 17 "Secretary." The Secretary of Agriculture of the

- 1 Commonwealth.
- 2 "Task force." The Pollinator Task Force established under
- 3 section 3(a).
- 4 Section 3. Pollinator Task Force.
- 5 (a) Establishment.--The Pollinator Task Force is established
- 6 as an independent task force in which the department has primary
- 7 jurisdiction.
- 8 (b) Purposes.--The task force shall work in collaboration
- 9 with the department and other State departments and agencies,
- 10 representatives of the agriculture industry, representatives of
- 11 registered apiaries, representatives of academic institutions,
- 12 representatives of conservation organizations and other groups
- 13 to develop recommendations for supporting pollinator populations
- 14 and policies and practices to promote the conservation and
- 15 protection of pollinator species in this Commonwealth.
- 16 (c) Membership. -- The task force shall consist of five
- 17 members appointed in accordance with this section.
- 18 (d) Potential appointees. -- The following individuals shall
- 19 each recommend three individuals as potential appointees to the
- 20 task force:
- 21 (1) The secretary or a designee with experience,
- 22 knowledge and expertise with pollinators.
- 23 (2) The Secretary of Conservation and Natural Resources
- or a designee with experience, knowledge and expertise with
- 25 pollinators.
- 26 (3) The Secretary of Transportation or a designee with
- 27 experience, knowledge and expertise with pollinators.
- 28 (4) A representative of the Office of Health Equity,
- appointed by the Secretary of Health.
- 30 (5) A representative of the Office of Environmental

- 1 Justice, appointed by the Secretary of Environmental
- 2 Protection.
- 3 (e) List of potential appointees. -- The individuals specified
- 4 under subsection (d) shall develop a list of all the potential
- 5 appointees developed under subsection (d) and provide the list
- 6 to:
- 7 (1) The President pro tempore of the Senate.
- 8 (2) The Minority Leader of the Senate.
- 9 (3) The Speaker of the House of Representatives.
- 10 (4) The Minority Leader of the House of Representatives.
- 11 (f) Selection process.--
- 12 (1) Upon receiving the list of potential appointees
- under subsection (e), the legislative officers specified
- 14 under subsection (e) shall:
- 15 (i) Review the list and denote their preferred
- 16 choices for appointees.
- 17 (ii) Choose one appointee from the three potential
- appointees recommended by each of the five individuals
- specified under subsection (d), based on the results of
- their review and their preferred choices.
- 21 (2) In the event of a tie vote regarding the selection
- of an individual as an appointee under paragraph (1)(ii),
- another vote will be taken on the selection, with the
- 24 following individuals making the determination:
- 25 (i) The legislative leaders under subsection (e).
- 26 (ii) The chairperson of the Agriculture and Rural
- 27 Affairs Committee of the Senate.
- 28 (iii) The minority chairperson of the Agriculture
- and Rural Affairs Committee of the Senate.
- 30 (iv) The chairperson of the Agriculture and Rural

- 1 Affairs Committee of the House of Representatives.
- 2 (v) The minority chairperson of the Agriculture and
- 3 Rural Affairs Committee of the House of Representatives.
- 4 (g) Officers of task force.--
- 5 (1) The secretary shall serve as the chairperson of the task force.
- 7 (2) By a majority vote, the task force may elect a vice 8 chairperson and other officers as it deems necessary and 9 appropriate to facilitate the work of the task force.
- 10 (h) Operation of task force generally.--
- 11 (1) The task force may adopt bylaws, rules or procedures 12 that it deems necessary to accomplish its purposes.
- 13 (2) The task force shall establish rules of procedure to 14 govern the conduct of its members.
- 15 (3) The department shall provide administrative support 16 to the task force.
- 17 (i) Vacancy.--A vacancy on the task force shall be filled 18 for the unexpired term of an appointed member of the task force 19 in the same manner as the original appointment.
- 20 (j) Meetings.--
- 21 (1) Within 90 days of the effective date of this 22 subsection, the task force shall hold its initial meeting.
- 23 (2) The task force shall meet at least once quarterly 24 and shall hold other meetings as it deems necessary.
- 25 (k) Ouorum.--
- 26 (1) A majority of the members of the task force shall constitute a quorum.
- 28 (2) Action may be taken by the task force at a meeting 29 upon a vote of a quorum of its members present in person or 30 through electronic means.

- 1 (1) Compensation and expenses. -- Members of the task force
- 2 shall not be entitled to compensation for their services as
- 3 members but shall be entitled to reimbursement for actual and
- 4 necessary expenses incurred in the discharge of official duties
- 5 as members of the task force. A member of the task force shall
- 6 be reimbursed in accordance with Commonwealth policy in effect
- 7 for agencies under the Governor's jurisdiction.
- 8 (m) Records.--Meetings of the task force shall be subject to
- 9 the requirements of 65 Pa.C.S. Ch. 7 (relating to open
- 10 meetings).
- 11 Section 4. Powers and duties of task force.
- 12 Subject to section 5, the task force shall have the following
- 13 powers and duties:
- 14 (1) To work in collaboration with the department and
- other State departments and agencies, representatives of the
- agriculture industry, representatives of registered apiaries,
- 17 representatives of academic institutions, representatives of
- conservation organizations and other groups to develop
- 19 recommendations for supporting pollinator populations and
- 20 policies and practices to promote the conservation and
- 21 protection of pollinator species in this Commonwealth.
- 22 (2) To coordinate the collection of information and
- communication-related information on programs and incentives
- 24 with Federal, State and local government agencies and
- 25 regulatory authorities, academic institutions and apiary,
- 26 agriculture, conservation, environmental and pollinator
- 27 organizations.
- 28 (3) To investigate and study ways to conserve and
- 29 protect pollinators and strengthen pollinator populations in
- 30 this Commonwealth and prepare a report that includes, at a

1 minimum, the following: An overview of the status of pollinator 2 (i) 3 populations in this Commonwealth and the causes of population declines. 4 5 (ii) Recommendations regarding the following: Data collection and dissemination, benchmark 6 (A) 7 development, targeting practices and transparency for 8 grant making to promote the conservation and 9 protection of pollinators in this Commonwealth. 10 What practices may be applied to conserve, protect and strengthen pollinator populations in this 11 12 Commonwealth. 13 Ways in which laws, regulations and other 14 policies that regulate and support the conservation 15 and protection of pollinators in this Commonwealth 16 could be more effectively applied. 17 Ways in which programs and services offered 18 by the department and other State departments and 19 agencies could provide for more effective pollinator 20 conservation and protection measures. 21 Ways in which regulatory and other (E)22 departmental decision-making processes could provide 23 for more effective pollinator conservation and 24 protection measures. 25 The ongoing role of the task force in 26 supporting the implementation and monitoring of the 27 goals specified in this act. (4) Not later than July 1, 2023, and each July 1 28 29 thereafter, to prepare an annual report. The following apply: 30 The report shall contain recommendations and

- 1 provide an update on the status of the task force's
- 2 activities relative to the ways in which laws,
- 3 regulations and other policies could more effectively
- 4 provide for the conservation and protection of
- 5 pollinators in this Commonwealth.
- 6 (ii) The report shall be transmitted to the
- 7 following:
- 8 (A) The Governor.
- 9 (B) The department.
- 10 (C) The Agriculture and Rural Affairs Committee
- of the Senate.
- 12 (D) The Agriculture and Rural Affairs Committee
- of the House of Representatives.
- 14 Section 5. Access to information and records.
- 15 (a) Logging of information. -- When the task force collects
- 16 information relating to pollinators, apiaries, agriculture,
- 17 conservation, pesticides, the environment or any other issue
- 18 related to pollinators, the task force shall log the information
- 19 and identify the Commonwealth agency providing the information.
- 20 (b) Right-to-Know requests. -- Records relating to the task
- 21 force shall be made available for access under the act of
- 22 February 14, 2008 (P.L.6, No.3), known as the Right-to-Know Law.
- 23 Section 6. Effective date.
- 24 This act shall take effect in 60 days.
