AN ACT

- 1 Providing for prohibition on importation or sale of dogs and
- cats, for duty of persons, kennels and animal testing
- facilities to offer dogs and cats for adoption and for
- whistleblower protection; and imposing penalties.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Beagle
- 9 Freedom Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Animal testing facility." A facility, including a private
- 15 entity, State agency or an institution of higher education, that
- 16 confines and uses dogs or cats for research, education, testing
- 17 or other scientific or medical purposes. The term shall include
- 18 any of the following:
- 19 (1) A kennel or facility subject to the Public Health

- 1 Service Policy on Humane Care and Use of Laboratory Animals
- 2 provided for under the Public Health Service Act (58 Stat.
- 3 682, 42 U.S.C. § 201 et seq.).
- 4 (2) A kennel or facility subject to the provisions of 21
- 5 CFR Pt. 58 (relating to good laboratory practice for
- 6 nonclinical laboratory studies) under the Federal Food, Drug,
- 7 and Cosmetic Act (52 Stat. 1040, 21 U.S.C. § 301 et seq.) or
- 8 the Public Health Service Act.
- 9 (3) A research kennel licensed under the Dog law.
- 10 "Animal Welfare Act." The Animal Welfare Act (Public Law 89-
- 11 544, 7 U.S.C. § 2131 et seq.) and its attendant regulations.
- 12 "Dealer." A person who in the regular course of business for
- 13 compensation or profit buys, sells, transfers, exchanges or
- 14 barters dogs and cats. The term does not include any of the
- 15 following:
- 16 (1) A person who transports companion animals in the
- 17 regular course of business as a common carrier.
- 18 (2) A person whose primary purpose is to find permanent
- 19 adoptive homes for companion animals.
- "Department." The Department of Agriculture of the
- 21 Commonwealth.
- "Dog Law." The act of December 7, 1982 (P.L.784, No.225),
- 23 known as the Dog Law.
- "Kennel." As defined in section 102 of the Dog Law.
- 25 "Police officer." As defined in section 102 of the Dog Law.
- 26 "Releasing agency." As defined in section 901-A of the Dog
- 27 Law.
- 28 "Research." As defined in section 102 of the Dog Law.
- 29 "Research kennel." As defined in section 102 of the Dog Law.
- 30 "State dog warden." As defined in section 102 of the Dog

- 1 Law.
- 2 Section 3. Prohibition on importation or sale of dogs and cats.
- 3 Notwithstanding the provisions of section 908 of the Dog Law,
- 4 a dealer or kennel may not import for sale, sell or offer for
- 5 sale, including a sale for research purposes, a dog or cat bred
- 6 by a person who has received any of the following from the
- 7 United States Department of Agriculture as authorized under the
- 8 Animal Welfare Act:
- 9 (1) A citation for a direct or critical violation or
- 10 citations for three or more indirect or noncritical
- violations during the two-year period before the procurement
- of the dog or cat.
- 13 (2) Two consecutive citations for no access to a housing
- 14 facility before the procurement of the dog or cat.
- 15 Section 4. Duty of persons, kennels and animal testing
- facilities to offer dogs and cats for adoption.
- 17 (a) Duties.--
- 18 (1) If any person, kennel or animal testing facility
- specified under paragraph (2) does not have a need for a dog
- or cat in its possession and the dog or cat does not pose a
- 21 health or safety risk to the public or the welfare of the dog
- or cat, the person, kennel or animal testing facility shall
- offer for release the dog or cat to a releasing agency for
- 24 eventual adoption or for adoption through a private
- 25 placement. In the case of an animal testing facility operated
- 26 by a State agency or an institution of higher education, the
- animal testing facility may develop its own adoption program.
- 28 (2) Paragraph (1) shall apply only to the following:
- 29 (i) A person who raises cats regulated under Federal
- 30 law as research animals or sells or transfers cats to an

- 1 animal testing facility.
- 2 (ii) A kennel that breeds dogs regulated under
- Federal law as research animals.
- 4 (iii) A kennel that sells or transfers dogs to an
- 5 animal testing facility or a research kennel.
- 6 (iv) An animal testing facility.
- 7 (3) Any person, kennel or animal testing facility
- 8 subject to this subsection shall keep the offer for release
- 9 under paragraph (1) available for a reasonable period of time
- 10 for a duration of up to 21 days before euthanizing a dog or
- 11 cat specified under paragraph (1).
- 12 (b) Implementation. -- Any person, kennel or animal testing
- 13 facility under subsection (a) may enter into an agreement with a
- 14 releasing agency to implement the requirements under subsection
- 15 (a).
- 16 (c) Liability. -- Any person, kennel or animal testing
- 17 facility under subsection (a) shall not be liable for civil
- 18 damages for a dog or cat adopted under subsection (a).
- 19 (d) Annual reports. -- Any person, kennel or animal testing
- 20 facility under subsection (a) shall annually submit a report to
- 21 the department stating the number of dogs and cats that were
- 22 adopted under subsection (a) and the name of each releasing
- 23 agency utilized by the person, kennel or animal testing
- 24 facility.
- 25 Section 5. Recordkeeping requirements for persons and kennels
- 26 engaged in the raising of dogs or cats for research
- purposes.
- 28 (a) Requirements.--
- 29 (1) A person or kennel specified under paragraph (2) and
- 30 engaged in the raising of dogs or cats for research purposes

- shall keep accurate records of all of the following:
- 2 (i) A dog or cat purchased, acquired, owned, held or
- 3 otherwise in the possession or control of the person or
- 4 kennel.
- (ii) A dog or cat transported, euthanized, sold or otherwise disposed of during the two-year period from the
- 7 date of the purchase, acquisition, transfer or
- 8 disposition of the dog or cat.
- 9 (2) Paragraph (1) shall apply only to the following:
- 10 (i) A person who raises cats regulated under Federal
- law as research animals or sells or transfers cats to an
- 12 animal testing facility.
- 13 (ii) A kennel that breeds dogs regulated under
- 14 Federal law as research animals.
- 15 (iii) A kennel that sells or transfers dogs to an
- animal testing facility or a research kennel.
- 17 (b) Records. -- The records under subsection (a) shall include
- 18 all of the following:
- 19 (1) The name and address of the person from whom a dog
- or cat was purchased or acquired and the person's license or
- 21 registration number if the person is licensed or registered
- 22 under the Animal Welfare Act.
- 23 (2) The date on which a dog or cat was purchased or
- 24 acquired.
- 25 (3) The name and address of the person to whom a dog or
- cat was sold, given or transferred and the person's license
- or registration number if the person is licensed or
- 28 registered under the Animal Welfare Act.
- 29 (4) The official United States Department of
- 30 Agriculture's tag number or tattoo assigned to a dog or cat

- 1 under the Animal Welfare Act.
- 2 (5) A description of a dog or cat, including all of the following:
- 4 (i) The species and breed or type.
- 5 (ii) The sex.
- 6 (iii) The date of birth or approximate age.
- 7 (iv) The color and distinctive markings.
- 8 (6) The date and number of offspring born of a dog or 9 cat while in the possession or under the control of the 10 person or kennel under subsection (a).
- 11 (7) Medical care and vaccinations provided to a dog or cat.
- 13 (8) The date and method of disposition of a dog or cat,
 14 including the sale, death and cause of death of the dog or
 15 cat if the disposition is not euthanasia, adoption or
 16 transfer.
- 17 (9) The number of dogs or cats in the possession of the 18 person or kennel under subsection (a) that the person or 19 kennel does not need.
- 20 (10) The number of dogs or cats described under
 21 paragraph (9) that have been offered for transfer to a
 22 releasing agency for eventual adoption or for adoption
 23 through private placement.
- 24 (c) Inspections.--A person or kennel under subsection (a)
- 25 shall ensure that the records under subsection (a) are legible
- 26 and the records shall be open to inspection and may be copied by
- 27 an employee of the department, State dog warden or police
- 28 officer.
- 29 (d) Submission. -- A person or kennel under subsection (a)
- 30 shall annually submit a summary of the records under subsection

- 1 (a) to the department in a form determined by the department.
- 2 Section 6. Whistleblower protection.
- 3 An employee of any person, dealer, kennel, animal testing
- 4 facility, private entity, State agency or institution of higher
- 5 education subject to this act shall be deemed to be an employee
- 6 under the act of December 12, 1986 (P.L.1559, No.169), known as
- 7 the Whistleblower Law, with regard to a good faith report of a
- 8 potential violation of this act, the Dog Law or the Animal
- 9 Welfare Act. Any dealer, kennel, animal testing facility,
- 10 private entity, State agency or institution of higher education
- 11 subject to this act shall be deemed to be an employer under the
- 12 Whistleblower Law with regard to a good faith report of a
- 13 potential violation of this act, the Dog Law or the Animal
- 14 Welfare Act.
- 15 Section 7. Annual report.
- No later than July 1, 2023, and each July 1 thereafter, the
- 17 department shall submit a report summarizing the information
- 18 collected under this act and complaints, enforcement activities
- 19 and penalties authorized under this act to the following:
- 20 (1) The chair and minority chair of the Agriculture and
- 21 Rural Affairs Committee of the Senate.
- 22 (2) The chair and minority chair of the Agriculture and
- 23 Rural Affairs Committee of the House of Representatives.
- 24 Section 8. Penalties.
- 25 A violation of this act shall constitute a misdemeanor of the
- 26 third degree.
- 27 Section 9. Regulations.
- The department may promulgate regulations as necessary to
- 29 implement this act.
- 30 Section 10. Effective date.

1 This act shall take effect in 120 days.
