## AN ACT

- 1 Providing for the Pennsylvania Officer Down Advisory;
- authorizing and directing the Pennsylvania State Police to
- 3 establish and maintain the Pennsylvania Officer Down
- Advisory; assessing costs; and providing for immunity and
- 5 penalties.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Pennsylvania
- 10 Officer Down Advisory Act.
- 11 Section 2. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- "Law enforcement officer." A Federal, State or local law
- 16 enforcement officer.
- 17 Section 3. Pennsylvania Officer Down Advisory established.

- 1 The Pennsylvania State Police shall establish and maintain
- 2 the Pennsylvania Officer Down Advisory to assist, through prompt
- 3 notification to the general public and appropriate law
- 4 enforcement authorities, in the apprehension of those suspected
- 5 of killing or seriously injuring law enforcement officers. The
- 6 Pennsylvania State Police shall establish such protocols and
- 7 procedures as are necessary for the effective operation of this
- 8 advisory and shall educate and inform local law enforcement
- 9 agencies and the public with regard to its availability. At a
- 10 minimum the following criteria must be met to activate the
- 11 advisory:
- 12 (1) A law enforcement officer must have been killed or
- seriously injured by a suspect.
- 14 (2) The investigating law enforcement agency must
- determine that the suspect poses a serious risk or threat to
- 16 the public or other law enforcement personnel.
- 17 (3) A detailed description of the make and model of the
- suspect's vehicle or a complete or partial registration plate
- 19 number of the suspect's vehicle must be available for
- 20 broadcast to the public.
- 21 (4) The investigating law enforcement agency having
- jurisdiction must recommend activation of the advisory.
- 23 Section 4. Prohibited use.
- 24 The transmission, broadcast or other communication of a
- 25 public alert, other than through the Pennsylvania Officer Down
- 26 Advisory, intentionally, knowingly, recklessly or negligently
- 27 purporting to be made by, with or through the authority of the
- 28 Pennsylvania Officer Down Advisory is prohibited and shall be
- 29 subject to a civil penalty of not more than \$5,000.
- 30 Section 5. Coordination with other jurisdictions.

- 1 The Pennsylvania State Police shall coordinate with the
- 2 authorities of the Federal Government and the various states
- 3 that are responsible within their respective jurisdictions for
- 4 the apprehension of those suspected of killing or seriously
- 5 injuring law enforcement officers to establish and execute the
- 6 procedures appropriate to the effective fulfillment of the
- 7 Pennsylvania State Police's responsibilities under section 3.
- 8 Section 6. Assessment of cost.
- 9 Unless a court finds that undue hardship would result, in
- 10 addition to any other cost imposed by law, a cost of \$25 shall
- 11 be assessed against each person convicted, adjudicated
- 12 delinquent or granted accelerated rehabilitative disposition
- 13 (ARD) of the offenses named in this section. The cost shall be
- 14 forwarded to the Commonwealth and used by the Pennsylvania State
- 15 Police to establish and maintain the Pennsylvania Officer Down
- 16 Advisory and shall apply to the following offenses:
- 17 18 Pa.C.S. § 2507 (relating to criminal homicide of law
- 18 enforcement officer).
- 19 18 Pa.C.S. § 2702.1 (relating to assault of law
- 20 enforcement officer).
- 21 18 Pa.C.S. § 5104 (relating to resisting arrest or other
- law enforcement).
- 23 18 Pa.C.S. § 5104.1 (relating to disarming law
- enforcement officer).
- 25 18 Pa.C.S. § 5511.2 (relating to police animals).
- 26 Section 7. Immunity.
- Owners, licensees, operators and employees of a communication
- 28 medium, including, but not limited to, telephone, radio,
- 29 television, newspaper, digital communications network, wireless
- 30 communications network or global communications network, shall

- 1 be immune from civil liability for their good faith conduct
- 2 while participating in accordance with this act.
- 3 Section 8. Effective date.
- 4 This act shall take effect in 30 days.
