AN ACT

Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in sexual offenses, providing for the 2 offense of female mutilation. 3 4 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 6 Section 1. Title 18 of the Pennsylvania Consolidated Statutes is amended by adding a section to read: 7 § 3132. Female mutilation. 8 9 (a) Offense defined. -- A person commits the offense of female mutilation if the person: 10 (1) knowingly circumcises, excises or infibulates the 11 12 whole or any part of the genitalia of a minor; 13 (2) is a parent of a minor and the parent knowingly 14 consents or permits the circumcision, excision or 15 infibulation of the whole or any part of the minor's 16 genitalia; or

(3) knowingly removes or permits the removal of a minor

- from this Commonwealth for the purpose of circumcising,
- 2 excising or infibulating, in whole or in part, the genitalia
- 3 of the minor.
- 4 (b) Grading.--Female mutilation is a felony of the first
- 5 degree.
- 6 (c) Exception. -- The provisions of subsection (a) shall not
- 7 apply if the circumcision, excision or infibulation is:
- 8 (1) necessary to the health of the minor on whom it is
- 9 performed and either is performed by a physician or is
- 10 performed in the presence of a physician by a person in
- 11 training to become a physician in accordance with the act of
- 12 October 5, 1978 (P.L.1109, No.261), known as the Osteopathic
- 13 <u>Medical Practice Act, or the act of December 20, 1985</u>
- 14 (P.L.457, No.112), known as the Medical Practice Act of 1985;
- 15 <u>or</u>
- 16 (2) performed on a minor in labor or who has just given
- 17 birth and is performed for medical reasons connected with
- 18 that labor or birth by a physician or in the presence of a
- 19 physician by a person in training to become a physician in
- 20 accordance with the Osteopathic Medical Practice Act or the
- 21 Medical Practice Act of 1985.
- 22 (d) Custom or consent not a defense. -- It shall not be a
- 23 <u>defense to a prosecution under this section that:</u>
- 24 (1) the actor believed that the procedure was necessary
- or appropriate as a matter of custom, ritual or standard
- 26 practice; or
- 27 (2) the minor upon whom the circumcision, excision or
- 28 infibulation was performed consented to the procedure or that
- 29 <u>the minor's parent consented to the procedure.</u>
- 30 (e) Definitions.--As used in this section, the following

- 1 words and phrases shall have the meanings given to them in this
- 2 <u>subsection unless the context clearly indicates otherwise:</u>
- 3 "Minor." A natural person who is a female under 18 years of
- 4 <u>age.</u>
- 5 <u>"Parent." The term includes a natural parent, stepparent,</u>
- 6 <u>adoptive parent, quardian or custodian of the minor.</u>
- 7 Section 2. This act shall take effect in 60 days.
