AN ACT

- Designating a portion of Pennsylvania Route 22 in Mifflin County as the Corporal John S. Valent Memorial Highway.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Corporal John S. Valent Memorial Highway.
- 6 (a) Findings.--
- 7 (1) Corporal John S. Valent was born on July 22, 1922,
- 8 in Blandburg, Cambria County, Pennsylvania.
- 9 (2) Corporal Valent served for three years in the United
- 10 States Navy during World War II.
- 11 (3) Corporal Valent enlisted in the Pennsylvania State
- 12 Police on February 1, 1946, at 23 years of age.
- 13 (4) Corporal Valent served honorably in the Pennsylvania
- 14 State Police for 25 years.

- 1 (5) Corporal Valent was killed in the line of duty on
- 2 December 9, 1971, while on patrol on State Route 22 in
- 3 Granville Township, Mifflin County.
- 4 (6) At 49 years of age, Corporal Valent became the 67th
- 5 member of the Pennsylvania State Police to make the ultimate
- 6 sacrifice in service to the Commonwealth of Pennsylvania.
- 7 (b) Designation. -- The section of Pennsylvania Route 22 in
- 8 Mifflin County from the intersection of West 4th Street and
- 9 Reservoir Lane in Lewistown Borough to the intersection of
- 10 Business 22 and Industrial Park Road in Granville Township,
- 11 Mifflin County, is hereby designated the Corporal John S. Valent
- 12 Memorial Highway.
- 13 (c) Signs.--The Department of Transportation shall erect and
- 14 maintain appropriate signs displaying the name of the highway to

- 15 traffic in both directions on the highway.
- 16 Section 2. Effective date.
- 17 This act shall take effect immediately IN 60 DAYS.
