7	Section 1. Title 15 of the Pennsylvania Consolidated
8	Statutes is amended by adding a section to read:
9	§ 5111. Eligibility for receipt of State resources.
10	(a) ConditionsA domestic nonprofit corporation or a
11	foreign nonprofit corporation with 200 or more employees in this
12	Commonwealth shall not be eligible for a State contract, State
13	funding or a State grant if the corporation:
14	(1) has violated 29 U.S.C. Ch. 8 (relating to fair labor
15	standards) within the previous five years;
16	(2) has been found guilty of an unfair labor practice in
17	this Commonwealth within the previous five years; or
18	(3) fails to submit to the Department of State current

1 bylaws of the corporation, which must provide that at least 2 20% of the members of the governing board of the corporation are current employees of the corporation and are elected by 3 the employees of the corporation. 4 5 (b) Applicability.--(1) Subsection (a) shall not apply in the case of health 6 care-related money payable from the Commonwealth to the 7 domestic nonprofit corporation or foreign nonprofit 8 9 corporation, which shall include Medicaid reimbursements. (2) This section shall not apply if the condition 10 described in subsection (a) (1) or (2) occurred prior to the 11 effective date of this paragraph. 12 Section 2. The addition of 15 Pa.C.S. § 5111 shall apply to 13 14 the following: 15 (1) A State contract entered into or renewed on or after the effective date of this section. 16 State funding approved or otherwise made on or after 17 (2)the effective date of this section. 18 19 (3) A State grant approved on or after the effective 20 date of this section. 21 Section 3. This act shall take effect in 60 days.
