## AN ACT

- 1 Providing for Keystone First Responder Award.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Keystone
- 6 First Responder Award Act.
- 7 Section 2. Award.
- 8 (a) Award. -- The award shall consist of a plaque and a medal.
- 9 (b) Presentation. -- The Governor or the Governor's designee
- 10 shall present a Keystone First Responder Award to each recipient
- 11 or surviving next of kin during a public ceremony held on, or as
- 12 near as practicable to, September 11 of each year.
- 13 (c) Committee. -- The Keystone First Responder Award shall be
- 14 administered by a committee, which shall consist of:
- 15 (1) The State Fire Commissioner.
- 16 (2) The Director of the Pennsylvania Emergency

- 1 Management Agency.
- 2 (3) The Director of the Bureau of Emergency Medical
- 3 Services within the Department of Health.
- 4 (4) The Secretary of General Services.
- 5 (5) The Commissioner of Pennsylvania State Police.
- 6 (6) The President of the Pennsylvania Chiefs of Police
- 7 Association.
- 8 (d) Choice of recipients. -- The Governor shall choose, in
- 9 consultation with the committee, the recipients of the Keystone
- 10 First Responder Award for each year.
- 11 Section 3. First responder recipient.
- 12 (a) Recipient.--A Keystone First Responder Award shall be
- 13 awarded to:
- 14 (1) a first responder who suffers a career-ending injury
- in the line of duty;
- 16 (2) the surviving next of kin of a first responder who
- is killed or sustains a fatal injury in the line of duty;
- 18 (3) a Federal first responder or special agent who
- 19 suffers a career-ending injury in the line of duty assisting
- 20 a State or local law enforcement agency in this Commonwealth;
- 21 or
- 22 (4) the surviving next of kin of a Federal first
- 23 responder or special agent who sustains a fatal injury while
- 24 assisting a State or local law enforcement agency in this
- 25 Commonwealth.
- 26 (b) Submission of information to committee. -- Any individual
- 27 who has personal knowledge of a first responder who was killed
- 28 or suffered a career-ending injury in the line of duty, or a
- 29 Federal first responder or special agent who was killed or
- 30 suffered a career-ending injury assisting a State or local law

- 1 enforcement agency in this Commonwealth, may submit that
- 2 information in writing to the committee.
- 3 (c) Rules and guidelines. -- The committee shall establish
- 4 rules and guidelines for its operations, for the execution of
- 5 this act and for the submission of information under subsection
- 6 (b).
- 7 (d) Eligibility.--In order for a first responder to be
- 8 eligible for the award under this act, a first responder must
- 9 have been killed or suffered a career-ending injury while
- 10 actively responding to an emergency. The committee shall
- 11 determine whether or not a submission under subsection (b) is
- 12 eligible for consideration.
- 13 (e) Construction. -- Nothing in this act shall be construed to
- 14 have any bearing on:
- 15 (1) the act of June 2, 1915 (P.L.736, No.338), known as
- the Workers' Compensation Act;
- 17 (2) the act of June 28, 1935 (P.L.477, No.193), referred
- 18 to as the Enforcement Officer Disability Benefits Law;
- 19 (3) the act of June 24, 1976 (P.L.424, No.101), referred
- 20 to as the Emergency and Law Enforcement Personnel Death
- 21 Benefits Act; or
- 22 (4) any other determination of benefits.
- 23 (f) Purpose of award.--The Keystone First Responder Award
- 24 shall only be for recognition purposes.
- 25 (g) Definitions.--As used in this section, the following
- 26 words and phrases shall have the meanings given to them in this
- 27 subsection unless the context clearly indicates otherwise:
- 28 "First responder." Any of the following:
- 29 (1) A current or former member of an emergency medical
- 30 services agency, fire company or rescue company.

- 1 (2) A peace officer.
- 2 (3) A 911 dispatcher.
- 3 (4) A coroner or medical examiner who responds in an
- 4 official capacity to an emergency.
- 5 (5) A corrections officer.
- 6 "Peace officer." As defined in 18 Pa.C.S. § 501 (relating to
- 7 definitions).
- 8 Section 4. Effective date.
- 9 This act shall take effect in 60 days.
