12	Section 1. Section 5(a) of the act of December 19, 1990 <
13	(P.L.1200, No.202), known as the Solicitation of Funds for

18	Section 5. Registration of charitable organizations; financial

reports; fees; failure to file.

2 Registration and approval required.--A charitable (a) 3 organization, unless exempted from registration requirements pursuant to section 6, shall file a registration statement with 4 5 the department. This statement must be refiled annually [within 6 135 days after] by the fifteenth day of the fifth month 7 following the close of its fiscal year in which the charitable 8 organization was engaged in solicitation activities. The department shall review the statement pursuant to subsection 9 (r). No charitable organization shall solicit contributions or 10 have contributions solicited in its behalf before approval of 11 12 its registration statement by the department.

14 (K) TIME EXTENSION FOR FILINGS. -- FOR GOOD CAUSE SHOWN, THE <---15 DEPARTMENT MAY EXTEND THE TIME FOR THE ANNUAL FILING OF A REGISTRATION STATEMENT OR FINANCIAL REPORT [FOR A PERIOD NOT TO 16 17 EXCEED 180 DAYS] TO A DATE NOT TO EXCEED THE FIFTEENTH DAY OF 18 THE ELEVENTH MONTH FOLLOWING THE CLOSE OF THE FISCAL YEAR DURING 19 WHICH TIME THE PREVIOUS REGISTRATION REMAINS IN EFFECT. 20 \* \* \*
