AN ACT

- Regulating tattoo, body-piercing and corrective cosmetic artists; limiting tongue splitting; providing for powers and duties of the Department of Health; and imposing penalties.

- 1 Section 15. Effective date.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Tattoo, Body-
- 6 piercing and Corrective Cosmetic Artists Act.
- 7 Section 2. Legislative intent.
- 8 It is the intent of the General Assembly to direct the
- 9 Department of Health to establish health standards for the
- 10 practice of tattooing, body piercing and corrective cosmetics
- 11 within this Commonwealth. This will be achieved through the
- 12 imposition of regulations and the registration of all tattoo
- 13 artists, body-piercing artists and corrective cosmetic artists
- 14 with the Department of Health.
- 15 Section 3. Definitions.
- 16 The following words and phrases when used in this act shall
- 17 have the meanings given to them in this section unless the
- 18 context clearly indicates otherwise:
- 19 "Body piercing." The process of breaching the skin or mucous
- 20 membrane for the purpose of insertion of any object, including,
- 21 but not limited to, jewelry for cosmetic purposes. The term does
- 22 not include ear piercing or nail piercing.
- "Body-piercing artist." Any person who actually performs
- 24 body piercing or who operates, conducts or manages any body-
- 25 piercing establishment.
- 26 "Corrective cosmetic artist." Any person who actually
- 27 performs corrective cosmetics.
- 28 "Corrective cosmetics." The application of tattoos on a live
- 29 human being for medical situations that otherwise could not be
- 30 corrected or improved, including, but not limited to, burn

- 1 scars, acne scars, age spots and skin discoloration due to loss
- 2 of pigmentation.
- 3 "Department." The Department of Health of the Commonwealth.
- 4 "Facial tattoo." A tattoo applied above the neck, including,
- 5 but not limited to, eyelids, eyebrows or lips.
- 6 "Infectious disease." A disease of humans or animals
- 7 resulting from a transmissible infection, whether or not patent,
- 8 apparent, inapparent, latent, clinical or subclinical.
- 9 "Registry." The Tattoo, Body-piercing and Corrective
- 10 Cosmetic Artists Central Registry.
- "Sanitization." The reduction of the population of
- 12 microorganisms to safe levels as determined by public health
- 13 officials.
- "Sterilization." The process of destruction of all forms of
- 15 life by physical or chemical means.
- 16 "Tattoo." The indelible mark, figure or decorative design
- 17 introduced by insertion of nontoxic dyes or pigments into or
- 18 under the subcutaneous portion of the skin or by the production
- 19 of scars upon the body of a live human being.
- 20 "Tattoo artist." Any person who actually performs tattooing
- 21 or who operates, conducts or manages any tattoo establishment.
- 22 "Tattooing." The process by which the skin is marked or
- 23 colored by insertion of nontoxic dyes or pigments into or under
- 24 the subcutaneous portion of the skin so as to form indelible
- 25 marks for cosmetic or figurative purposes.
- 26 "Temporary establishment." An establishment which performs
- 27 tattooing, body piercing, or both, is operated by an individual
- 28 registered under this act and which operates outside of a
- 29 registered facility at a fixed location for a period of time of
- 30 not more than seven consecutive days in conjunction with a

- 1 single event or celebration.
- 2 "Tongue splitting." The cutting of a human tongue into two
- 3 or more parts.
- 4 Section 4. Registry.
- 5 The department shall, by regulation, establish the Tattoo,
- 6 Body-piercing and Corrective Cosmetic Artists Central Registry.
- 7 All persons who perform tattooing, body-piercing or corrective
- 8 cosmetic services within this Commonwealth must meet the
- 9 requirements of this act and register with the department on
- 10 forms provided by the department.
- 11 Section 5. Powers and duties of department.
- 12 (a) General rule. -- The department, in the exercise of its
- 13 duties under this act, shall have the power to adopt such
- 14 regulations as are reasonably necessary to carry out the
- 15 purposes of this act. Regulations shall be adopted in conformity
- 16 with the provisions of the act of June 25, 1982 (P.L.633, No.
- 17 181), known as the Regulatory Review Act, and shall include, but
- 18 not be limited to:
- 19 (1) Tattoo, body-piercing and corrective cosmetic
- 20 establishment registration and facility registration
- 21 requirements, including, but not limited to:
- 22 (i) Physical location.
- 23 (ii) Specifications of walls, ceilings, floors,
- partitions, fixtures, equipment and other appurtenances.
- 25 (iii) Lighting.
- 26 (iv) Ventilation.
- (v) Water supply.
- 28 (vi) Liquid waste disposal.
- 29 (vii) Refuse storage and disposal.
- 30 (viii) Toilets and lavatories.

- 1 (ix) Sinks.
- 2 (x) Insect and rodent control.
- 3 (2) Temporary establishment registration requirements.
- 4 (3) Tattoo artist and body-piercing artist registration requirements.
- 6 (4) Apprentice tattoo artist and body-piercing artist 7 registration requirements.
- 8 (5) Development and maintenance of and registration in 9 the registry.
- 10 (6) Tattoo artist and body-piercing artist hygiene.
- 11 (7) Health, sanitization, sterilization and safety
 12 standards for tattoo, body-piercing or corrective cosmetic
 13 establishments and temporary establishments.
- 14 (8) Tattoo and body-piercing establishment and temporary
 15 establishment recordkeeping.
- 16 (9) Qualifications for the registration of corrective cosmetic artists.
- 18 (10) Tongue splitting.
- 19 (b) Examination. -- The department shall require the
- 20 successful completion of a written examination regarding health,
- 21 sanitization, sterilization and safety standards prior to
- 22 issuing a registration to any tattoo artist, body-piercing
- 23 artist or corrective cosmetic artist.
- 24 (c) Registration. -- The department shall register:
- 25 (1) Any applicant who successfully passes the
 26 examination and meets the requirements for registration in
 27 accordance with the regulations promulgated under this act.
- (2) Any tattoo or body-piercing establishment or
 temporary establishment which has been inspected and meets
 facility requirements in accordance with the regulations

- where tattooing, body-piercing or corrective cosmetic
- 2 services will be performed.
- 3 (d) Inspection. -- The department shall inspect every
- 4 establishment at which tattooing, body piercing or corrective
- 5 cosmetics are performed prior to issuing a facility
- 6 registration. The department may also conduct inspections of
- 7 registered facilities and temporary establishments as the
- 8 department deems necessary to carry out this act. The inspection
- 9 shall insure that required sterilization, sanitation and safety
- 10 standards are maintained.
- 11 (e) Fees.--All fees required under this act shall be fixed
- 12 by the department by regulation and shall be subject to the act
- 13 of June 25, 1982 (P.L.633, No.181), known as the Regulatory
- 14 Review Act.
- 15 (f) Limitation. -- Nothing in this act shall be construed to
- 16 permit the department to regulate artistic aspects of tattooing,
- 17 body piercing or corrective cosmetics which are unrelated to
- 18 health, sanitization, sterilization or safety standards.
- 19 (g) Departmental actions. -- All actions of the department in
- 20 accordance with this act which result in a refusal to issue a
- 21 registration for reasons other than failure to pass a written
- 22 examination required by this act or action which suspends or
- 23 revokes a registration shall be subject to the right of notice,
- 24 hearing and adjudication and the right of appeal therefrom in
- 25 accordance with 2 Pa.C.S. Ch. 5 Subch. A (relating to practice
- 26 and procedure of Commonwealth agencies).
- 27 Section 6. Duties and responsibilities of artists.
- 28 (a) Health of tattoo artists and body-piercing artists.--The
- 29 department shall establish by regulation minimum health
- 30 standards for all registrants and persons working in any area of

- 1 a tattoo or body-piercing establishment which may be necessary
- 2 to prevent the contamination of tattoo or body-piercing
- 3 equipment, supplies or work surfaces with pathogenic organisms.
- 4 (b) Infectious disease. -- A notarized statement from a
- 5 licensed physician shall be provided to the department, prior to
- 6 the issuance of a registration under this act, confirming that
- 7 the artist was examined by the physician, a test of the artist's
- 8 blood was made and the results of that test indicate that:
- 9 (1) the artist is free from all contagious and
- 10 infectious diseases, including hepatitis B;
- 11 (2) the artist has either completed or was offered and
- 12 declined a vaccination series;
- 13 (3) antibody testing reveals that the artist is immune
- 14 to certain diseases; or
- 15 (4) a vaccine is contradicted for medical reasons.
- 16 (c) Notifications. -- Verbal and written instructions for the
- 17 care of the tattooed or pierced site on the body shall be
- 18 provided to each customer by the tattoo artist or body-piercing
- 19 artist upon the completion of the procedure. The written
- 20 instructions shall advise the customer to consult a physician at
- 21 the first sign of infection and contain the name, address and
- 22 telephone number of the tattoo or body-piercing establishment.
- 23 Section 7. Minors.
- 24 (a) Prohibitions.--It shall be unlawful for any person to
- 25 perform tattooing or body-piercing services on any other person
- 26 under 18 years of age without the written consent of a parent or
- 27 legal guardian of that other person.
- 28 (b) Regulations.--The department shall promulgate
- 29 regulations establishing standards for verification of age and
- 30 documentation of consent.

- 1 (c) Revocation. -- Any person who performs tattooing or body-
- 2 piercing services on any body part of a person under 18 years of
- 3 age without proper consent as established in subsection (a)
- 4 shall have the registration under this act revoked for two
- 5 years.
- 6 (d) Registration. -- Any person who violates subsection (a)
- 7 may not be registered for two years from the date of violation
- 8 or revocation, whichever is later.
- 9 Section 8. Powers of municipalities.
- 10 (a) Municipal ordinances preserved. -- Nothing in this act
- 11 shall supersede the power of a municipality to inspect tattoo or
- 12 body-piercing establishments or temporary establishments, to
- 13 regulate the manner in which tattooing or body piercing may be
- 14 performed, to levy lawful taxes and fees and to require the
- 15 purchase of a business privilege license unrelated to competence
- 16 in the practice of tattooing or body piercing. No municipality
- 17 shall require a tattoo artist or body-piercing artist registered
- 18 under this act to obtain a municipal license to engage in
- 19 tattoo, temporary tattoo or body-piercing services in the
- 20 municipality. Nothing in this act shall preclude a municipality
- 21 from denying or revoking a local permit for failure to comply
- 22 with a local ordinance not inconsistent with this act or
- 23 regulations of the department promulgated under this act.
- 24 (b) Failure to comply with local ordinance. -- A registrant
- 25 under this act who fails to comply with a municipal ordinance
- 26 concerning the inspection of tattoo or body-piercing
- 27 establishments or temporary establishments, or the manner in
- 28 which the municipality requires tattoo and body-piercing
- 29 services to be performed, shall be subject to disciplinary
- 30 proceedings under this act.

- 1 Section 9. Unlawful acts.
- 2 (a) Unregistered practice. -- It is unlawful for any person to
- 3 practice tattooing, body piercing or corrective cosmetics, or to
- 4 hold himself out as a practitioner of or entitled or authorized
- 5 to practice tattooing, body piercing or corrective cosmetics, or
- 6 to assume any title of "tattooist," "tattoo artist," "body-
- 7 piercer, " "body-piercing artist, " "corrective cosmetics artist"
- 8 or other letters or titles in connection with that person's name
- 9 which in any way represents himself as being engaged in the
- 10 practice of tattooing, body piercing or corrective cosmetics, or
- 11 authorized to do so, unless that person has been duly registered
- 12 and authorized to engage in the practice under this act.
- 13 (b) Unregistered facilities. -- It is unlawful for any person
- 14 to operate a tattoo, body-piercing or corrective cosmetic
- 15 establishment or temporary establishment that is not registered
- 16 with the department.
- 17 (c) Injections.--It is unlawful for a tattoo artist, body-
- 18 piercing artist or corrective cosmetic artist to administer
- 19 anesthetic injections or other medications and prescription
- 20 drugs.
- 21 (d) Facial tattoos. -- It is unlawful for any person other
- 22 than a corrective cosmetic artist registered under this act, or
- 23 a physician or surgeon licensed in this Commonwealth, to perform
- 24 facial tattoo services on any other person.
- 25 Section 10. Tongue splitting limitation.
- 26 (a) General rule. -- A person shall not perform tongue
- 27 splitting on another person unless the tongue splitting is
- 28 performed by a physician or dentist licensed in this
- 29 Commonwealth.
- 30 (b) Grading.--Any person who violates the provisions of this

- 1 section commits a misdemeanor of the first degree for a first
- 2 offense and a felony of the third degree for a second or
- 3 subsequent offense.
- 4 Section 11. Disciplinary matters.
- 5 (a) General. -- The department may suspend or revoke any
- 6 registration issued under this act for any of the following
- 7 reasons:
- 8 (1) Failing to demonstrate the qualifications or
- 9 standards for a registration contained in this act or
- 10 regulations of the department.
- 11 (2) Making misleading, deceptive, untrue or fraudulent
- 12 representations in obtaining a registration.
- 13 (3) Being unable to practice with reasonable skill and
- safety to the public by reason of illness, addiction to drugs
- or alcohol, having been convicted of a felonious act
- 16 prohibited by the act of April 14, 1972 (P.L.233, No.64),
- 17 known as The Controlled Substance, Drug, Device and Cosmetic
- 18 Act, or convicted of a felony relating to a controlled
- 19 substance in a court of law of the United States or any other
- state, territory, possession or country, or of mental
- 21 incompetency. An applicant's statement on the application
- 22 declaring the absence of a conviction shall be deemed
- 23 satisfactory evidence of the absence of a conviction unless
- the department has some evidence to the contrary.
- 25 (4) Violating a lawful regulation promulgated by the
- department or violating a lawful order of the department
- 27 previously entered by the department in a disciplinary
- 28 proceeding.
- 29 (5) Knowingly maintaining a professional connection or
- 30 association with any person who is in violation of this act

- or regulation of the department or knowingly aiding,
- 2 assisting, procuring or advising any unregistered person to
- 3 practice a profession contrary to this act or regulations of
- 4 the department.
- 5 (6) Acting in such manner as to present an immediate and
- 6 clear danger to public health or safety.
- 7 (7) Making a false or deceptive biennial registration
- 8 with the department.
- 9 (b) Authorized actions. -- In addition to taking disciplinary
- 10 or corrective action against a registrant under this act or
- 11 pursuant to other statutory authority, the department may:
- 12 (1) Deny the application for a registration or any other
- privilege granted by the department.
- 14 (2) Revoke, suspend, limit or otherwise restrict a
- 15 registration.
- 16 (3) Stay enforcement of any suspension and place a
- 17 registrant on probation with the right to vacate the
- 18 probationary order for noncompliance.
- 19 (c) Failure to comply with conditions. -- Failure of a
- 20 registrant to comply with the conditions required by the
- 21 department shall be grounds for reconsideration of the matter
- 22 and institution of formal charges against the registrant.
- 23 (d) Reinstatement of registration. -- Unless ordered to do so
- 24 by the Commonwealth Court or on appeal therefrom, the department
- 25 may not reinstate the registration of a person which has been
- 26 revoked for two years from the date of violation or revocation,
- 27 whichever is later. Any person whose registration has been
- 28 revoked may apply for reinstatement, after a period of at least
- 29 two years, but must meet all of the registration requirements of
- 30 this act, including the examination requirement, if that person

- 1 desires to practice the art of tattooing, body piercing or
- 2 corrective cosmetics under this act at any time after such
- 3 revocation.
- 4 (e) Surrender of suspended or revoked registration. -- The
- 5 department shall require a person whose registration has been
- 6 suspended or revoked to return the registration in such manner
- 7 as the department directs.
- 8 Section 12. Penalties.
- 9 Any person who violates any provision of this act commits a
- 10 misdemeanor of the third degree and shall, upon conviction, be
- 11 sentenced to pay a fine of not more than \$1,000 or to
- 12 imprisonment for not more than three months, or both.
- 13 Section 13. Injunctive relief.
- 14 It shall be unlawful for any person to practice or attempt to
- 15 offer to practice tattooing, body piercing or corrective
- 16 cosmetics without having at the time of so doing a valid,
- 17 unexpired, unrevoked and unsuspended registration issued under
- 18 this act. The unlawful practice of tattooing, body piercing or
- 19 corrective cosmetics may be enjoined by the courts on petition
- 20 of the department. In any such proceeding it shall not be
- 21 necessary to show that any person is individually injured by the
- 22 actions complained of. If it is found that the respondent has
- 23 engaged in the unlawful practice of tattooing or body piercing,
- 24 the court shall enjoin the respondent from so practicing unless
- 25 and until the respondent registers with the department. This
- 26 procedure in such cases shall be the same as in any other
- 27 injunction suit. The remedy by injunction authorized by this
- 28 section shall be in addition to any other civil or criminal
- 29 prosecution and punishment authorized by law.
- 30 Section 14. Exemptions.

- 1 (a) General rule. -- Nothing in this act shall prevent:
- 2 (1) a physician or surgeon licensed in this Commonwealth
- 3 from performing body-piercing or tattooing services for
- 4 medical reasons; or
- 5 (2) a funeral director licensed in this Commonwealth
- from performing body-piercing or tattooing services as
- 7 required by that profession.
- 8 (b) Physician-based corrective cosmetics establishments.--
- 9 Nothing in this act shall require the registration of corrective
- 10 cosmetics establishments physically located in a licensed
- 11 physician's office, hospital or clinic. Those establishments
- 12 shall also be exempt from facility requirements as provided for
- 13 in section 5(a)(1).
- 14 Section 15. Effective date.
- This act shall take effect as follows:
- 16 (1) Section 5(a) shall take effect in two years.
- 17 (2) Section 10 shall take effect in 60 days.
- 18 (3) This section shall take effect immediately.
- 19 (4) The remainder of this act shall take effect in 180
- 20 days.
