AN ACT

To provide from the General Fund for the expenses of the Executive and Judicial Departments, the State Government 2 Support Agencies and the General Assembly of the 3 Commonwealth, the public debt and the public schools for the 4 5 fiscal year July 1, 2017, to June 30, 2018, for certain institutions and organizations and for the payment of bills 6 7 incurred and remaining unpaid at the close of the fiscal year ending June 30, 2017; to provide appropriations from the 8 State Lottery Fund, the Tobacco Settlement Fund, the Aviation 9 Restricted Account, the Hazardous Material Response Fund, The 10 State Stores Fund, the Milk Marketing Fund, the Home 11 Investment Trust Fund, the Emergency Medical Services 12 Operating Fund, the Tuition Account Guaranteed Savings 13 Program Fund, the Banking Fund, the Firearm Records Check 14 Fund, the Ben Franklin Technology Development Authority Fund, 15 the Oil and Gas Lease Fund, the Home Improvement Account, the 16 Cigarette Fire Safety and Firefighter Protection Act 17 Enforcement Fund, the Commonwealth Financing Authority Debt 18 Service Restricted Revenue Account, the Insurance Regulation 19 and Oversight Fund, the Pennsylvania Racehorse Development 20 21 Restricted Receipt Account, the Justice Reinvestment Fund, the Multimodal Transportation Fund, the State Racing Fund and 22 the ABLE Savings Program Fund to the Executive Department; to 23 provide appropriations from the Judicial Computer System 24 25 Augmentation Account to the Judicial Department for the fiscal year July 1, 2017, to June 30, 2018; to provide 26 appropriations from the Motor License Fund for the fiscal 27 year July 1, 2017, to June 30, 2018, for the proper operation of several departments of the Commonwealth and the 28 29 Pennsylvania State Police authorized to spend Motor License 30 31 Fund money; to provide for the appropriation of Federal funds 32 to the Executive and Judicial Departments of the Commonwealth 33 and for the payment of bills remaining unpaid at the close of the fiscal year ending June 30, 2017; and to provide for the 34 additional appropriation of Federal and State funds from the 35

- General Fund, the State Lottery Fund and the Tobacco 1
- Settlement Fund for the Executive and Legislative Departments 2

- 11 repairs, freight, express and cartage, postage, telephones and
- 12 telegraph rentals and toll charges, newspaper advertising and
- 13 notices, public advertising by or through any medium, fuel,
- 14 light, heat, power and water, minor construction and renovation,
- 15 repairs or reconstruction of equipment, buildings and
- 16 facilities, rent of real estate and equipment, premiums on
- 17 workers' compensation, insurance premiums on policies of
- 18 liability insurance, insurance premiums on medical payment
- 19 insurance and surety bonds for volunteer workers, premiums on
- 20 employee group life insurance and employee and retired employee
- 21 group hospital and medical insurance, payment of Commonwealth
- 22 share of Social Security taxes and unemployment compensation
- 23 costs for State employees, the purchase of replacement or
- 24 additional equipment and machinery and all other incidental
- 25 costs and expenses, including payment to the Department of
- 26 General Services of mileage and other charges for the use of
- 27 automobiles and rental payments for permanently assigned
- 28 automobiles and of expenses or costs of services incurred
- 29 through the Purchasing Fund. The term "expenses" also shall
- 30 include the medical costs for the treatment of inmates of State

- 2 hospital, provided, that in no case shall the State institution
- 3 pay more for patient care than that provided under the State

- 26 Section 2101. Prior laws unaffected.
- 27 This act is not intended to be inconsistent with or to repeal
- 28 any provision of any act enacted at this or any prior session of

- 30 ordering of printing and binding, the purchase, maintenance and

- 1 use of automobiles, the method of making payments from the State
- 2 Treasury for any purpose or the functioning of any

- 4 Section 2102. Compliance with other law before funds available.
- 5 No appropriation made by this act to any department, board,
- 6 commission or agency of the Executive Department shall be
- 7 available unless and until the department, board, commission or

- 9 April 9, 1929 (P.L.177, No.175), known as The Administrative
- 10 Code of 1929.
- 11 Section 2103. Contracts prerequisite to encumbering or

- 13 Funds available to agencies, boards, departments, commissions
- 14 or other governmental entities under this act for the
- 15 procurement of supplies, services or construction shall not be
- 16 available for payment of or to be committed to or encumbered for
