AN ACT

Amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, providing for exclusion of veterans' benefits from income calculations. 4 The General Assembly of the Commonwealth of Pennsylvania 5 hereby enacts as follows: 6 Section 1. The following words and phrases when used in this chapter

- 1 shall have the meanings given to them in this section unless the
- 2 <u>context clearly indicates otherwise:</u>
- 3 <u>"Veterans' benefit." A service-connected compensation or</u>
- 4 <u>benefit of any kind provided to a veteran by a Federal or State</u>
- 5 agency or authorized under Federal or State law, including, but
- 6 not limited to, pensions, disability payments and rebates.
- 7 § 9702. Veterans' benefits excluded from income calculations
- 8 <u>for Commonwealth programs.</u>
- 9 (a) General rule. -- All veterans' benefits shall be excluded
- 10 from calculations of income or assets for determining
- 11 eligibility for any Commonwealth benefit program, tax exemption,
- 12 <u>fee exemption or rebate.</u>
- 13 (b) Extension to spouses. -- The exclusion under subsection
- 14 (a) shall apply to an unmarried surviving spouse upon the death
- 15 of a veteran for any veterans' benefit the unmarried surviving
- 16 spouse is entitled to receive under applicable Federal or State
- 17 law.
- 18 Section 2. This act shall take effect in 60 days.
