AN ACT

Authorizing the release of Project 70 restrictions on certain lands owned by the Commonwealth of Pennsylvania, acting by 2 and through the Department of Conservation and Natural 3 Resources, in exchange for the imposition of Project 70 4 restrictions on other lands to be acquired by the 5 Commonwealth of Pennsylvania, acting by and through the 6 Department of Conservation and Natural Resources. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Restrictions on property owned by the Commonwealth, 10 11 acting by and through the Department of Conservation 12 and Natural Resources. 13 (a) Authorization. -- Under the requirements of section 20(b) of the act of June 22, 1964, (Sp. Sess., P.L.131, No.8), known 14 15 as the Project 70 Land Acquisition and Borrowing Act, the 16 General Assembly hereby authorizes the release of Project 70 17 restrictions on land owned by the Commonwealth, acting by and through the Department of Conservation and Natural Resources, 18 19 which is more particularly described in subsection (b), in exchange for the imposition of Project 70 restrictions on land, 20 which is more particularly described in subsection (c). 21

- 1 (b) Land to be released from Project 70 restrictions.--The
- 2 land to be released from Project 70 restrictions is as follows:
- 3 ALL THOSE CERTAIN tracts or parcels of land situate in Upper
- 4 Uwchlan Township, Chester County, Pennsylvania, being bounded

- 17 conveyed unto the Commonwealth of Pennsylvania.
- 18 (c) Land subject to the imposition of Project 70
- 19 restrictions. -- The land to be acquired by the Commonwealth,
- 20 acting by and through the Department of Conservation and Natural
- 21 Resources, on which Project 70 restrictions are to be imposed,
- 22 is as follows:
- 23 ALL THAT CERTAIN parcel of land situated in Wallace Township,
- 24 Chester County, Pennsylvania, being a PART OF UPI 31-4-145,
- 25 being a Turnpike Mitigation Area according to a new survey
- 26 thereof as shown on a Plan of Property Boundary Survey for
- 27 Natural Lands, prepared by Beideman Associates, Glenmoore,
- 28 Pennsylvania, dated February 22, 2018, and being more fully
- 29 described as follows:
- 30 BEGINNING AT AN INTERIOR POINT, a corner of a

- 1 County/State/Highlands Funding Area, and on line of land of the
- 2 Commonwealth of Pennsylvania (UPI 31-4-146); which INTERIOR
- 3 POINT OF BEGINNING is located as follows from the point of
- 4 intersection of the title line in Marshall Road (S.R. 4033) and
- 5 the title line in Chalfont Road (T-423), being at the
- 6 intersection of Little Conestoga Road (S.R. 4016) extending to
- 7 the north and east, Marshall Road extending to the west, and
- 8 Chalfont Road extending to the south; commencing thence along
- 9 the title line in Chalfont Road and along the Charles Andrews
- 10 Subdivision recorded in Plan Book 56 Page 13, the three (3)
- 11 following courses and distances: 1) South 14 degrees 34 minutes
- 12 31 seconds East 585.32 feet to a point; 2) crossing through the
- 13 Andrews Lane intersection, South 20 degrees 24 minutes 31
- 14 seconds 369.89 East feet to a point; and 3) South 30 degrees 30
- 15 minutes 31 seconds East 363.53 feet to a point; thence
- 16 continuing along the title line in Chalfont Road and along the
- 17 Chalfont-St. Giles Subdivision recorded as Plan Number 13270,
- 18 crossing through the Waterview Drive intersection, South 21
- 19 degrees 33 minutes 32 seconds East 411.98 feet to a point, a
- 20 corner of land of the Commonwealth of Pennsylvania (UPI 31-4-
- 21 146); thence leaving Chalfont Road and along said land of the
- 22 Commonwealth of Pennsylvania, South 44 degrees 35 minutes 45
- 23 seconds West 65.60 feet to a corner of the herein described
- 24 Turnpike Mitigation Area, an interior point and the TRUE POINT
- 25 OF BEGINNING; THENCE FROM THE TRUE POINT OF BEGINNING, along
- 26 said land of the Commonwealth of Pennsylvania, crossing a
- 27 copperweld found at a distance of 19.24 feet, South 44 degrees
- 28 35 minutes 45 seconds West a total distance of 1165.92 feet to a
- 29 concrete monument found at a corner of land of Philadelphia
- 30 Suburban Water Company, now Aqua Pennsylvania, Inc. (UPI 31-4-

- 1 143); thence along said land, North 38 degrees 22 minutes 44
- 2 seconds West 183.64 feet to a corner of the aforementioned
- 3 County/State/Highlands Funding Area; thence through UPI 31-4-145
- 4 of which this is a part, and along the County/State/Highlands
- 5 Funding Area, North 44 degrees 35 minutes 45 seconds East
- 6 1224.02 feet to a point; thence along the same, South 21 degrees
- 7 33 minutes 32 seconds East 199.27 feet to the point of
- 8 beginning.
- 9 CONTAINING 5.000 acres of land be the same more or less.
- 10 BEING PART OF UPI Number 31-4-145.
- 11 BEING A PART OF THE SAME PREMISES which Dekamodo Investment
- 12 Partnership, L.P., by deed dated December 19, 2017, and recorded
- 13 December 29, 2017, in the Office of the Recorder of Deeds in and
- 14 for the County of Chester, Pennsylvania, in Record Book 9675
- 15 Page 243, granted and conveyed to Natural Lands Trust, a
- 16 Pennsylvania non-profit corporation.
- 17 (d) Clause. -- Project 70 restrictions shall be imposed on the
- 18 lands described in subsection (c) by the following deed clause:
- 19 This land to be used for park, recreation, and conservation
- 20 purposes in accordance with provisions of the act of June 22,
- 21 1964 (Sp. Sess., P.L. 131, No. 8), known as the Project 70 Land
- 22 Acquisition and Borrowing Act.
- 23 (e) Easements. -- The conveyances described in this section
- 24 shall be subject to all lawful and enforceable easements,
- 25 servitudes and rights of others, including but not confined to
- 26 streets, roadways and rights of any telephone, telegraph, water,
- 27 electric, gas or pipeline companies, as well as under and
- 28 subject to any lawful and enforceable estates or tenancies
- 29 vested in third persons appearing of record, for any portion of
- 30 the land or improvements erected thereon.

- 1 Section 2. Effective date.
- 2 This act shall take effect immediately.
