AN ACT

- Providing for voluntary student expression of religious
 viewpoints in public schools; requiring public school
 districts to allow religious expression in class assignments,
 to provide students with the freedom to organize religious
 groups and activities and to provide a limited public forum
 for student speakers at nongraduation and graduation events;
 and providing for a model policy for voluntary religious
 expression in public schools.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. Short title.
- 12 This act shall be known and may be cited as the Student
- 13 Religious Liberties Act.
- 14 Section 2. Definitions.
- The following words and phrases when used in this act shall
- 16 have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:
- 18 "Department." The Department of Education of the
- 19 Commonwealth.
- 20 "Public school entity." Any of the following:

- 1 (1) A school district, as defined in section 102 of the
- 2 act of March 10, 1949 (P.L.30, No.14), known as the Public
- 3 School Code of 1949.
- 4 (2) A charter school, cyber charter school or regional
- 5 charter school, as defined in section 1703-A of the Public
- 6 School Code of 1949.
- 7 (3) An intermediate unit, as established under Article
- 8 IX-A of the Public School Code of 1949.
- 9 (4) An area career and technical school, as established
- 10 under Article XVIII of the Public School Code of 1949.
- 11 Section 3. Student expression.
- 12 (a) Prohibition. -- A public school entity may not
- 13 discriminate against a student or parent on the basis of a
- 14 religious viewpoint or religious expression.
- 15 (b) Treatment. -- A public school entity shall treat a
- 16 student's voluntary expression of a religious viewpoint on an
- 17 otherwise permissible subject in the same manner that the public
- 18 school entity treats a student's voluntary expression of a
- 19 secular or other viewpoint on an otherwise permissible subject
- 20 and may not discriminate against the student based on a
- 21 religious viewpoint expressed by the student on an otherwise
- 22 permissible subject.
- 23 Section 4. Religious expression in a class assignment.
- 24 (a) Expression permitted. -- A student may express the
- 25 student's beliefs about religion in homework, artwork and other
- 26 written and oral assignments free from discrimination based on
- 27 the religious content of the submission. Homework and
- 28 assignments must be judged by ordinary academic standards of
- 29 substance and relevance and against other legitimate pedagogical
- 30 concerns identified by the public school entity.

- 1 (b) Penalty or reward prohibited.--
- 2 (1) A public school entity may not penalize or reward a 3 student based on the religious content of the student's work.
- If an assignment requires a student's viewpoint to 4 (2) 5 be expressed in coursework, artwork or written or oral 6 assignments, a public school entity may not penalize or 7 reward a student on the basis of religious content or a 8 religious viewpoint. In evaluating an assignment under this 9 paragraph, a public school entity shall evaluate a student's 10 academic work that expresses a religious viewpoint based on ordinary academic standards of substance and relevance to the 11 12 course curriculum or requirements of the coursework or 13 assignment.
- 14 Section 5. Freedom to organize a religious group and activity.
- 15 (a) Time.--A student enrolled in a public school entity may
- 16 pray or engage in a religious activity or religious expression
- 17 before, during and after the school day in the same manner and
- 18 to the same extent as a student may engage in secular activities
- 19 or expression.
- 20 (b) Organization. -- A student enrolled in a public school
- 21 entity may organize a prayer group, religious club or other
- 22 religious gathering before, during and after the school day to
- 23 the same extent as a student is permitted to organize a secular,
- 24 noncurricular student group or activity.
- 25 (c) Access.--A public school entity shall provide a
- 26 religious group with the same access to a school facility for
- 27 assembling as the public school entity provides to secular,
- 28 noncurricular groups without discrimination based on the
- 29 religious content of the students' expression or religious
- 30 viewpoint of the group.

- 1 (d) Advertisement. -- If a public school entity permits a
- 2 student group that meets for secular activities to use school
- 3 premises, property or services to advertise or announce group
- 4 meetings, the public school entity shall permit a student group
- 5 that meets for prayer or other religious speech the same access
- 6 to school premises, property or services to advertise or
- 7 announce group meetings.
- 8 (e) Disclaimer. -- A public school entity may disclaim school
- 9 sponsorship of noncurricular groups and events in a manner that
- 10 neither favors nor disfavors groups that meet to engage in
- 11 prayer or religious speech.
- 12 (f) Clothing. -- A student enrolled in a public school entity
- 13 may wear clothing, accessories and jewelry that display a
- 14 religious message or religious symbol in the same manner and to
- 15 the same extent that a student may wear clothing, accessories
- 16 and jewelry that display a secular message or symbol.
- 17 Section 6. Limited public forum.
- 18 (a) General rule. -- A public school entity shall establish a
- 19 limited public forum for student speakers at any school event at
- 20 which a student will publicly speak and shall:
- 21 (1) Not discriminate against a student's voluntary
- 22 expression of a religious viewpoint on an otherwise
- 23 permissible subject.
- 24 (2) Develop and utilize a method, based on neutral
- criteria, for the selection of one or more student speakers
- at school events, including, but not limited to, a graduation
- ceremony.
- 28 (3) Ensure that a student speaker does not engage in
- 29 obscene, vulgar, offensively lewd or indecent speech.
- 30 (4) State in writing or orally, or both, that the

- 1 student's speech does not reflect the endorsement,
- 2 sponsorship, position or expression of the public school
- 3 entity. The disclaimer required under this paragraph shall be
- 4 provided at graduation ceremonies and at any other event in
- 5 which a student speaks publicly.
- 6 (b) Exclusion prohibited. -- A public school entity may not
- 7 exclude student expression on an otherwise permissible subject
- 8 from the limited public forum because the student expresses a
- 9 religious viewpoint.
- 10 Section 7. Policy.
- 11 (a) Model policy. -- Not later than October 1, 2023, the
- 12 department shall develop a model policy for public school
- 13 entities that is consistent with this act. The department shall
- 14 post the model policy on its publicly accessible Internet
- 15 website.
- 16 (b) Public school entity policy.--
- 17 (1) Not later than January 1, 2024, each public school
- 18 entity shall:
- 19 (i) adopt the model policy developed by the
- department under subsection (a);
- 21 (ii) develop and adopt its own policy related to
- 22 student religious liberties that is consistent with this
- 23 act; or
- 24 (iii) amend an existing policy related to student
- religious liberties in a manner consistent with this act.
- 26 (2) The public school entity shall post the policy
- 27 required under paragraph (1) on its publicly accessible
- Internet website, if available, in every classroom and at a
- 29 prominent location within each school building where such
- 30 policies are usually posted.

- 1 Section 8. Limitations.
- 2 (a) Participation not required. -- This act shall not be
- 3 construed to authorize this Commonwealth or any public school
- 4 entity to do any of the following:
- 5 (1) Require an individual to participate in prayer or in
- 6 any other religious activity.
- 7 (2) Violate the constitutional rights of an individual.
- 8 (b) Authority preserved. -- This act may not be construed to
- 9 limit the authority of a public school entity to do any of the
- 10 following:
- 11 (1) Maintain order and discipline on its school campus
- in a manner that does not discriminate against a student's
- religious viewpoint or the religious content of a student's
- 14 expression.
- 15 (2) Protect the safety of a student, employee or visitor
- of a school.
- 17 (3) Adopt and enforce policies and procedures regarding
- 18 student speech at school if the policies and procedures do
- not violate the rights of students under the Constitution of
- the United States and the laws of this Commonwealth.
- 21 Section 9. Effective date.
- This act shall take effect July 1, 2023, or immediately,
- 23 whichever is later.
