12 (a) General rule.--A written request for access to records 13 may be submitted in person, by mail, by e-mail, by facsimile or, 14 to the extent provided by agency rules, by any other electronic 15 means. A written request must be addressed to the open-records 16 officer designated pursuant to section 502. Employees of an agency shall be directed to forward requests for records to the 17 18 open-records officer. A written request should identify or 19 describe the records sought with sufficient specificity to 20 enable the agency to ascertain which records are being requested 21 and shall include the name and address to which the agency 22 should address its response. (b) Reason for request.--Except as provided in subsection
(c), a written request need not include any explanation of the
requester's reason for requesting or intended use of the records
unless otherwise required by law.

27 (c) Commercial purpose.--A written request for the 28 duplication of a record shall include a statement indicating 29 whether or not the requester intends to use the record for a 30 commercial purpose.
