AN ACT

1 To provide appropriations from the General Fund for the expenses
2 of the Executive, Legislative and Judicial Departments of the
3 Commonwealth, the public debt and the public schools for the
4 fiscal year July 1, 2021, to June 30, 2022, and for the
5 payment of bills incurred and remaining unpaid at the close
6 of the fiscal year ending June 30, 2021; to provide
7 appropriations from special funds and accounts to the
8 Executive and Judicial Departments for the fiscal year July
9 1, 2021, to June 30, 2022, and for the payment of bills
10 remaining unpaid at the close of the fiscal year ending June
11 30, 2021; to provide for the appropriation of Federal funds
12 to the Executive and Judicial Departments for the fiscal year
13 July 1, 2021, to June 30, 2022, and for the payment of bills
14 remaining unpaid at the close of the fiscal year ending June
15 30, 2021; and to provide for the additional appropriation of
16 Federal and State funds to the Executive and Judicial
17 Departments for the fiscal year July 1, 2020, to June 30,
18 2021, and for the payment of bills incurred and remaining
19 unpaid at the close of the fiscal year ending June 30, 2020.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 PART I
9 GENERAL PROVISIONS

10 Section 101. Short title.

11 This act shall be known and may be cited as the General
12 Appropriation Act of 2021.

13 Section 102. Definitions.

14 The following words and phrases when used in this act shall
15 have the meanings given to them in this section unless the
16 context clearly indicates otherwise:

17 "COVID-19." The coronavirus disease 2019, also referred to
18 as 2019-nCoV acute respiratory disease.

19 "Current fiscal year." The fiscal year beginning July 1,
20 2021, and ending June 30, 2022.

21 "Employees." Includes all directors, superintendents, bureau
22 or division chiefs, assistant directors, assistant
23 superintendents, assistant chiefs, experts, scientists,
24 engineers, surveyors, draftsmen, accountants, secretaries,
25 auditors, inspectors, examiners, analysts, statisticians,
26 marshals, clerks, stenographers, bookkeepers, messengers and
27 other assistants in a department, board or commission.

28 "Expenses" and "maintenance." Includes all printing, binding
29 and stationery, food and forage, materials and supplies,
30 traveling expenses, training, motor vehicle supplies and

1 repairs, freight, express and cartage, postage,
2 telecommunication devices and telecommunication rentals and toll
3 charges, newspaper advertising and notices, public advertising
4 by or through any medium, fuel, light, heat, power and water,
5 minor construction and renovation, repairs or reconstruction of
6 equipment, buildings and facilities, rent of real estate and
7 equipment, premiums on workers' compensation, insurance premiums
8 on policies of liability insurance, insurance premiums on
9 medical payment insurance and surety bonds for volunteer
10 workers, premiums on employee group life insurance and employee
11 and retired employee group hospital and medical insurance,
12 payment of Commonwealth share of Social Security taxes and
13 unemployment compensation costs for State employees, the
14 purchase of replacement or additional equipment and machinery
15 and all other incidental costs and expenses, including payment
16 to the Department of General Services of mileage and other
17 charges for the use of motor vehicles and rental payments for
18 permanently assigned motor vehicles and of expenses or costs of
19 services incurred through the Purchasing Fund. The term
20 "expenses" also shall include the medical costs for the
21 treatment of inmates of State institutions when the inmate must
22 be transferred to an outside hospital, provided that in no case
23 shall the State institution pay more for patient care than that
24 provided under the State medical assistance program.

25 "Prior fiscal year." The fiscal year beginning July 1 of the
26 fiscal year immediately prior to the current fiscal year.

18 (a) General Fund.--Except as provided in Part XIX, the sums
19 specified in this act, or as much thereof as may be necessary,
20 are specifically appropriated from the General Fund to agencies
21 of the Executive, Legislative and Judicial Departments of the
22 Commonwealth for the payment of salaries, wages or other
23 compensation and travel expenses of the duly elected or
24 appointed officers and employees of the Commonwealth, for the
25 payment of fees for contractual services rendered, for the
26 purchase or rental of goods and services, printing, public
27 advertising by or through any medium, equipment, land and
28 buildings and for payment of any other expenses, as provided by
29 law or by this act, necessary for the proper conduct of the
30 duties, functions and activities and for the purposes specified

1 in this act for the current fiscal year and for the payment of
2 bills incurred and remaining unpaid at the close of the prior
3 fiscal year.

4 (b) Special funds and accounts.--Except as provided in Part
5 XIX, the sums specified in this act, or as much thereof as may
6 be necessary, are specifically appropriated from the special
7 funds and accounts in the State Treasury to agencies of the
8 Executive and Judicial Departments of the Commonwealth for the
9 payment of salaries, wages or other compensation and travel
10 expenses of the duly appointed officers and employees of the
11 Commonwealth, for the payment of fees for contractual services
12 rendered, for the purchase or rental of goods and services and
13 for payment of any other expenses, as provided by law or by this
14 act, necessary for the proper conduct of the duties, functions
15 and activities and for the purposes specified in this act for
16 the current fiscal year and for the payment of bills incurred
17 and remaining unpaid at the close of the prior fiscal year.
18 Section 105. Federal appropriations.

19 Except as otherwise provided in section 1902, the Federal
20 appropriations specified in this act, or as much thereof as may
21 be necessary, are specifically appropriated to the agencies of
22 the Executive Department of the Commonwealth specified in this
23 act for the payment of the expenses of implementing and carrying
24 out the programs specified in this act for the current fiscal
25 year and for the payment of bills incurred and remaining unpaid
26 at the close of the prior fiscal year. Unless otherwise stated,
27 the Federal appropriations include any carryovers from the prior
28 fiscal year.

15 any provision of any act enacted at this or any prior session of
16 the General Assembly regulating the purchase of supplies, the
17 ordering of printing and binding, the purchase, maintenance and
18 use of motor vehicles, the method of making payments from the
19 State Treasury for any purpose or the functioning of any
20 administrative department, board or commission.

21 Section 7102. Compliance with other law before funds available.

22 No appropriation made by this act to any department, board,
23 commission or agency of the Executive Department shall be
24 available unless and until the department, board, commission or
25 agency has complied with sections 615 and 616 of the act of
26 April 9, 1929 (P.L.177, No.175), known as The Administrative
27 Code of 1929.

28 Section 7103. Contracts prerequisite to encumbering or
29 committing funds.

30 Funds available to agencies, boards, departments, commissions

1 or other governmental entities under this act for the
2 procurement of supplies, services or construction shall not be
3 available for payment of or to be committed to or encumbered for
4 payment of the procurement unless and until the agency, board,
5 department or other governmental entity has complied with all of
6 the requirements applicable to the procurement that are
7 specified in 62 Pa.C.S. (relating to procurement) and in the
8 policies, procedures and regulations instituted in accordance
9 with 62 Pa.C.S.

10 Section 7104. Minority business set-asides.

11 (a) Duty to report.--Each department or other
12 instrumentality of the Commonwealth listed in Subpart A of Part
13 II authorized to contract for buildings, highways, commodities,
14 equipment, supplies or services shall report to the General
15 Assembly all information pertinent to anticipated procurement
16 needs at the beginning of each quarter during a fiscal year.

17 (b) Definition.--As used in this section, the term "minority
18 business" means a minority business enterprise as defined in the
19 act of July 22, 1974 (P.L.598, No.206), known as the
20 Pennsylvania Minority Business Development Authority Act.

21 Section 7105. Appropriation of funds from miscellaneous
22 sources.

23 In addition to the amounts appropriated by this act:

24 (1) Moneys received in payment for food and household
25 supplies furnished to employees and other persons, except
26 inmates, by an institution and moneys received from the
27 proceeds from the sale of products of the soil, meats,
28 livestock, timber or other materials sold by a department or
29 agency of the Commonwealth shall be paid into the General
30 Fund and are appropriated out of the General Fund to the

1 several respective institutions for the operation and
2 maintenance of the institutions.

3 (2) Moneys received from any other source, except the
4 Federal Government, as contributions for the purposes
5 specified in the respective appropriations or as payment for
6 services or materials furnished by one institution to
7 another, except those collections designated as revenues,
8 shall be paid into the General Fund and are appropriated out
9 of the General Fund for the purposes of the respective
10 appropriations.

11 (3) Moneys received by a department or agency of the
12 Commonwealth from other sources, except the Federal
13 Government, as contributions or supplements to the department
14 or agency for a program or administration of an act included
15 in this act shall be paid into the General Fund and credited
16 to the appropriation for that program or administration of
17 the act.

18 Section 7106. Lapsing of unused funds.

19 (a) General rule.--Except as otherwise provided by law or by
20 this section, that part of all appropriations in this act
21 unexpended, uncommitted or unencumbered as of the close of the
22 current fiscal year shall automatically lapse as of that day.

23 (b) Exceptions.--The following shall be continuing
24 appropriations:

25 (1) The appropriation in section 236 to the Health Care
26 Cost Containment Council.

27 (2) The appropriation in section 241 to the Supreme
28 Court for the unified judicial system security program.

29 (3) The appropriations in Subpart C of Part II to the
30 General Assembly.

1 (4) The appropriations in Subpart D of Part II to the
2 Government Support Agencies.

3 (c) Nonapplicability.--This section does not apply to Part
4 XIX.

5 Section 7107. Appellate courts appropriation contingency.

6 The appropriations in sections 241, 242 and 243 to the
7 Supreme, Superior and Commonwealth Courts, respectively, for
8 justice and judge expenses are contingent upon a vouchered
9 expense account plan being continued by the Supreme Court.

10 Section 7108. Transfer of excess funds.

11 The Governor may transfer moneys in funds receiving proceeds
12 of Commonwealth of Pennsylvania general obligation bonds in
13 excess of the amount necessary for the purposes for which the
14 bonds were issued to the appropriate sinking fund for payment of
15 debt service due on outstanding bonds. If the excess money,
16 together with any available balance, exceeds the amount of debt
17 service remaining to be paid, the money shall be transferred to
18 the General Fund or to the appropriate special fund responsible
19 for the debt service.

20 Section 7109. Transfers for government support agencies.

21 During the current fiscal year, any prior year amount
22 unexpended on the effective date of this section may, upon the
23 written concurrence of the President pro tempore of the Senate,
24 the Majority Leader of the Senate, the Speaker of the House of
25 Representatives and the Majority Leader of the House of
26 Representatives, be transferred between any of the following
27 accounts:

28 (1) Legislative Reference Bureau.

29 (2) Legislative Budget and Finance Committee.

30 (3) Legislative Data Processing Committee.

- 1 (4) Joint State Government Commission.
- 2 (5) Local Government Commission.
- 3 (6) Legislative Audit Advisory Commission.
- 4 (7) Center for Rural Pennsylvania.
- 5 (8) Commonwealth Mail Processing Center.
- 6 (9) Joint Legislative Air and Water Pollution Control
7 and Conservation Committee.
- 8 (10) Legislative Reapportionment Commission.
- 9 (11) Independent Regulatory Review Commission.
- 10 (12) Capitol Preservation Committee.
- 11 (13) Pennsylvania Commission on Sentencing.
- 12 (14) Host State Committee expenses - CSG.
- 13 (15) Restricted Account for Leave Payout Expenses.

14 Section 7110. Transfers for Legislative Reapportionment
15 Commission.

16 The appropriation in this act or in any other fiscal year to
17 the Legislative Reapportionment Commission remaining unexpended
18 and unencumbered on the effective date of this section may, upon
19 the written concurrence of the President pro tempore of the
20 Senate, the Majority Leader of the Senate, the Speaker of the
21 House of Representatives and the Majority Leader of the House of
22 Representatives, be transferred to any other account of the
23 Senate and the House of Representatives, as they deem necessary.

24 Section 7111. Administration of Human Services Block Grant.

25 The Department of Human Services shall allocate and disburse
26 appropriations in this act for the Human Services Block Grant
27 Program established under Article XIV-B of the act of June 13,
28 1967 (P.L.31, No.21), known as the Human Services Code, to
29 counties participating in that program. Each participating
30 county may adjust the expenditure of the county's Human Services

1 Block Grant Program allocation between those appropriations in
2 accordance with, and as authorized by, the applicable provision
3 of Article XIV-B of the Human Services Code.

5 MISCELLANEOUS PROVISIONS

6 Section 8101. Effective date.

7 This act shall take effect as follows:

8 (1) This section shall take effect immediately.

9 (2) The remainder of this act shall take effect July 1,
10 2021, or immediately, whichever is later.
