Amending Title 20 (Decedents, Estates and Fiduciaries) of the 1 Pennsylvania Consolidated Statutes, in grant of letters, 2 further providing for advertisement of grant of letters. 3 The General Assembly of the Commonwealth of Pennsylvania 4 5 hereby enacts as follows: Section 1. Section 3162(a) of Title 20 of the Pennsylvania 6 Consolidated Statutes is amended to read: § 3162. Advertisement of grant of letters. 8 9 (a) Notice generally .--10 The personal representative, immediately after the 11 grant of letters, shall cause notice thereof to be given [in one newspaper of general circulation published at or near the 12 place where the decedent resided or, in the case of a 13 14 nonresident decedent, at or near the place where the letters 15 were granted, and in the legal periodical, if any, designated 16 by rule of court for the publication of legal notices,]:(i) in the legal periodical, if any, designated by 17 rule of court for the publication of legal notices; 18 (ii) either: 19

1	(A) on the publicly accessible Internet website
2	of the register of wills in the county where letters
3	were granted according to fees established under
4	section 2.1 of the act of July 1, 1981 (P.L.191,
5	No.57), referred to as the Register of Wills Fee Law,
6	or, if the register of wills of the county does not
7	provide such website, in a newspaper of general
8	circulation published at or near the place where the
9	decedent resided; or
10	(B) a newspaper of general circulation published
11	at or near the place where the decedent resided or,
12	if the register of wills of the county does not
13	provide a publicly accessible Internet website for
14	publication, publication shall be made in a newspaper
15	of general circulation published at or near the place
16	where the decedent resided; and
17	(iii) in the case of a nonresident decedent, in a
18	newspaper of general circulation at or near the place
19	where the letters were granted.
20	(2) The notices required under paragraph (1)(i) and
21	(iii) shall be published once a week for three successive
22	weeks and, in the case of the notice required under paragraph
23	(1)(ii), continuously for a period of not less than three
24	successive weeks, together with [his] the personal
25	representative's name and address; and in every such notice,
26	[he] the personal representative shall request all persons
27	having claims against the estate of the decedent to make the
28	<pre>claims known [the same to him or his] to the personal</pre>
29	representative or the personal representative's attorney, and
30	all persons indebted to the decedent to make payment to [him]

- 1 <u>the personal representative</u> without delay.

- 3 Section 2. This act shall take effect in 60 days.
