## AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," providing for the definition of "nonpublic school"; and further providing for policy relating 5 6 7 to bullying. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 1301-A of the act of March 10, 1949 11 (P.L.30, No.14), known as the Public School Code of 1949, is 12 amended by adding a definition to read: 13 Section 1301-A. Definitions. -- As used in this article, 14 \* \* \* 15 "Nonpublic school" shall mean any school, other than a public 16 school within the Commonwealth of Pennsylvania, wherein a 17 resident of this Commonwealth may legally fulfill the compulsory school attendance requirements of this act. 18

- 2 (P.L.846, No.61), is amended to read:
- 3 Section 1303.1-A. Policy Relating to Bullying.--(a) No
- 4 later than January 1, 2009, each school entity shall adopt a
- 5 policy or amend its existing policy relating to bullying and
- 6 incorporate the policy into the school entity's code of student
- 7 conduct required under 22 Pa. Code § 12.3(c) (relating to school
- 8 rules). No later than January 1, 2014, each nonpublic school
- 9 shall adopt a policy or amend its existing policy relating to
- 10 bullying and make this policy available to students and the
- 11 public pursuant to subsection (b). The policy shall delineate
- 12 disciplinary consequences for bullying and may provide for
- 13 prevention, intervention and education programs, provided that
- 14 no school entity or nonpublic school shall be required to
- 15 establish a new policy under this section if one currently
- 16 exists and reasonably fulfills the requirements of this section.
- 17 The policy shall identify the appropriate school staff person to
- 18 receive reports of incidents of alleged bullying.
- 19 (b) Each school entity and nonpublic school shall make the
- 20 policy available on its publicly accessible Internet website, if
- 21 available, and in every classroom. Each school entity and
- 22 <u>nonpublic school</u> shall post the policy at a prominent location
- 23 within each school building where such notices are usually
- 24 posted. Each school entity and nonpublic school shall ensure
- 25 that the policy and procedures for reporting bullying incidents
- 26 are reviewed with students within ninety (90) days after their
- 27 adoption and thereafter at least once each school year.
- 28 (c) Each school entity <u>and nonpublic school</u> shall review its
- 29 policy every three (3) years and annually provide the office
- 30 with a copy of its policy relating to bullying, including

- 1 information related to the development and implementation of any
- 2 bullying prevention, intervention and education programs. [The]
- 3 For school entities, the information required under this
- 4 subsection shall be attached to or made part of the annual
- 5 report required under section 1303-A(b).
- 6 (d) In its policy relating to bullying adopted or maintained
- 7 under subsection (a), a school entity or nonpublic school shall
- 8 not be prohibited from defining bullying in such a way as to
- 9 encompass acts that occur outside a school setting if those acts
- 10 meet the requirements contained in subsection (e)(1), (3) and
- 11 (4). If a school entity reports acts of bullying to the office
- 12 in accordance with section 1303-A(b), it shall report all
- 13 incidents that qualify as bullying under the entity's adopted
- 14 definition of that term.
- 15 (e) For purposes of this article, "bullying" shall mean an
- 16 intentional electronic, written, verbal or physical act, or a
- 17 series of acts:
- 18 (1) directed at another student or students;
- 19 (2) which occurs in a school setting;
- 20 (3) that is severe, persistent or pervasive; and
- 21 (4) that has the effect of doing any of the following:
- 22 (i) substantially interfering with a student's education;
- 23 (ii) creating a threatening environment; or
- 24 (iii) substantially disrupting the orderly operation of the
- 25 school; and
- "school setting" shall mean in the school, on school grounds,
- 27 in school vehicles, at a designated bus stop or at any activity
- 28 sponsored, supervised or sanctioned by the school.
- 29 Section 3. This act shall take effect in 60 days.
