## AN ACT

- 1 Providing for airport systems to conduct 50/50 drawings and to
- donate half of ticket sales to a designated eligible
- 3 charitable organization.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Airport
- 8 System 50/50 Drawing Act.
- 9 Section 2. Legislative intent.
- 10 The General Assembly hereby declares that raising funds from
- 11 a 50/50 drawing conducted in airport systems located in a county
- 12 of the second class, the net proceeds of which will be used for
- 13 charitable purposes, is in the public interest.
- 14 Section 3. Definitions.
- 15 The following words and phrases when used in this act shall
- 16 have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:
- 18 "Airport." An airport situated in a county of the second

- 1 class and owned and controlled by a public authority created
- 2 under 53 Pa.C.S. Ch. 56 (relating to municipal authorities), the
- 3 former act of June 28, 1935 (P.L.463, No.191), known as the
- 4 Municipality Authorities Act of one thousand nine hundred and
- 5 thirty-five, or under the former act of May 2, 1945 (P.L.382,
- 6 No.164), known as the Municipality Authorities Act of 1945.
- 7 "Airport 50/50 drawing." A 50/50 drawing that is conducted
- 8 by an airport in accordance with this act.
- 9 "Airport system." One or more airports as defined in this
- 10 section.
- 11 Section 4. General rule.
- 12 A person may purchase one or more airport 50/50 drawing
- 13 tickets, and each ticket shall represent one entry in the
- 14 drawing for a winner. A single ticket shall be randomly chosen
- 15 as the winner after a certain number of tickets are sold or a
- 16 specified time period expires, as designated by the airport.
- 17 Section 5. Frequency and location.
- An airport 50/50 drawing may be conducted at an airport no
- 19 more than one time per calendar day. Drawings may only be held
- 20 within the spaces of an airport terminal to which the general
- 21 public, including ticketed passengers, regularly have access.
- 22 Section 6. Distribution.
- The prize amount of an airport 50/50 drawing shall be 50% of
- 24 the total amount collected from the sale of airport 50/50
- 25 drawing tickets. The other 50% of the total amount collected
- 26 from the sale of airport 50/50 drawing tickets shall be donated
- 27 within seven days from the date of the drawing by the airport to
- 28 the designated charitable organization for which the drawing was
- 29 conducted.
- 30 Section 7. Designated charitable organization.

- 1 The identity of the designated charitable organization for
- 2 which the airport 50/50 drawing is being conducted shall be
- 3 disclosed to all ticket purchasers.
- 4 Section 8. Eligibility.
- 5 In order to receive proceeds from an airport 50/50 drawing, a
- 6 charitable organization must be in existence and fulfill its
- 7 purposes prior to the airport 50/50 drawing and shall be
- 8 eligible for exemption under section 501(c)(3) of the Internal
- 9 Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 501(c)(3)).
- 10 A political subdivision shall not qualify as a charitable
- 11 organization under this act, but an organization formed by a
- 12 political subdivision that is eligible for exemption under
- 13 section 501(c)(3) of the Internal Revenue Code of 1986 shall
- 14 qualify as a charitable organization under this act.
- 15 Section 9. Unclaimed prizes.
- Any airport 50/50 drawing prize remaining unclaimed by a
- 17 winner 180 days after the drawing shall be donated to the
- 18 designated charitable organization for which the airport 50/50
- 19 drawing was conducted.
- 20 Section 10. Effective date.
- 21 This act shall take effect in 60 days.
