AN ACT

Amending the act of November 22, 1978 (P.L.1166, No.274), entitled "An act establishing the Pennsylvania Commission on 2 Crime and Delinquency, providing for its powers and duties 3 establishing several advisory committees within the commission and providing for their powers and duties," further providing for powers and duties of the commission; 6 and establishing the Law Enforcement Line of Duty Death Reward Fund. 8 9 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 11 Section 1. Section 3 of the act of November 22, 1978 12 (P.L.1166, No.274), referred to as the Pennsylvania Commission on Crime and Delinquency Law, is amended by adding a paragraph 14 to read: Section 3. Powers and duties of the commission. 15 16 The commission shall have the power and its duty shall be: * * * 17 18 (19) To offer and cause to be paid rewards of up to 19 \$50,000 for information leading to the arrest and conviction 20 of perpetrators of an offense under 18 Pa.C.S. § 2507 (relating to criminal homicide of law enforcement officer). 21

- 1 Section 2. The act is amended by adding a section to read:
- 2 <u>Section 8.2. Law Enforcement Line of Duty Death Reward Fund.</u>
- 3 (a) Establishment of fund. -- The Law Enforcement Line of Duty
- 4 Death Reward Fund is established as a special fund in the State
- 5 Treasury.
- 6 (b) Administration. -- The fund shall be administered by the
- 7 commission. The commission shall use moneys in the fund solely
- 8 for the purpose of section 3(19).
- 9 (c) Fund sources.--The sources of the fund are as follows:
- 10 (1) Moneys transferred under subsection (d).
- 11 (2) Contributions and donations to the fund.
- 12 (d) Transfers. -- Commencing with fiscal year 2012-2013 and
- 13 continuing annually thereafter, the sum of \$750,000 shall be
- 14 transferred from the State Gaming Fund to the Law Enforcement
- 15 Line of Duty Death Reward Fund.
- 16 (e) Definition. -- As used in this section, the term "fund"
- 17 means the Law Enforcement Line of Duty Death Reward Fund.
- 18 Section 3. This act shall take effect in 60 days.
