## AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, 2 3 primary and election expenses and election contests; creating and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, 6 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 7 8 revising and consolidating the laws relating thereto; and 9 repealing certain acts and parts of acts relating to 10 elections," in nomination of candidates, further providing 11 for casting of lots for position of names upon the primary 12 ballots or ballot labels and notice to candidates. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. Section 915 of the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, is amended to 17 18 read: 19 Section 915. Casting of Lots for Position of Names Upon the 20 Primary Ballots or Ballot Labels; Notice to Candidates. -- (a) 21 Immediately after the last day fixed for filing of such 22 nomination petitions with them, the Secretary of the

Commonwealth or the county board, as the case may be, shall fix

- 1 a day for the casting of lots, in such manner as may be
- 2 prescribed by the Secretary of the Commonwealth, or county
- 3 board, as the case may be, for the position of names upon the
- 4 primary ballots or ballot labels. The Secretary of the
- 5 Commonwealth shall give at least two (2) days notice by mail of
- 6 said date to all candidates whose petitions have been received
- 7 and filed in his office, and the county board shall give at
- 8 least two (2) days notice of said date by posting thereof in a
- 9 conspicuous place in its office, and by publication once in at
- 10 least two newspapers of general circulation published in the
- 11 county.
- 12 <u>(b)</u> All candidates may appear in person, or by agent duly
- 13 authorized by letter of attorney, signed and acknowledged by an
- 14 officer empowered to take acknowledgments. In the event of any
- 15 of said candidates not being present in person or by
- 16 representative at the time of casting of lots, it shall be the
- 17 duty of the Secretary of the Commonwealth or the county board,
- 18 as the case may be, to appoint some person to represent such
- 19 absentee.
- 20 (c) The lots shall be cast first by the candidates who
- 21 appear in person, and those candidates shall receive the highest
- 22 positions on the primary ballots. If there is only one absentee,
- 23 the absentee shall receive the lowest position on the primary
- 24 ballots. If there is more than one absentee, the lots shall be
- 25 drawn separately by the representatives for the absentees and
- 26 they shall receive the lowest positions on the primary ballots.
- 27 <u>(d)</u> After [said] <u>all</u> lots are cast, the Secretary of the
- 28 Commonwealth or the county board, as the case may be, shall
- 29 accordingly establish the order in which the names of said
- 30 candidates are to appear upon the primary ballots or ballot

- 1 labels, and certify the same for placing upon the official
- 2 primary ballots or ballot labels.
- 3 Section 2. This act shall take effect in 60 days.
