- 10 (P.L.491, No.45), known as the Pennsylvania Construction Code

- The following words and phrases when used in this act shall
- 14 have the meanings given to them in this section unless the
- 15 context clearly indicates otherwise:

- 17 <u>"Campground." An area on private property managed primarily</u>
- 18 for outdoor recreation purposes where the following amenities
- 19 are provided:

1 (1) tent or trailer spaces; (2) cabins for recreational purposes; 2 3 (3) drinking water; 4 (4) an access road; 5 (5) refuse containers; (6) toilet facilities; 6 (7) the personal collection of recreation use fees by an 7 8 employee of the camparound; 9 (8) reasonable visitor protection; or (9) devices for containing fires, if campfires are 10 permitted in the campground. 11 * * * 12 13 Section 2. Application. 16 (b) Exclusions. -- This act shall not apply to any of the 17 18 following: 19 20 (11) A pre-engineered and prefabricated cabin intended 21 for recreational purposes on a campground which is: (i) Delivered to a campground and placed as an 2.2 23 already-completed structure. 24 (ii) Utilized only for recreational activity by the 25 general public. 2.6 (iii) Not utilized as a domicile or residence for an individual for any time period. 2.7 28 (iv) Not greater than one story in height. 29 (v) Not greater than 750 square feet in total area, not including deck or porch areas that are an integral 30

2	(vi) Equipped with at least one smoke detector, one
3	fire extinguisher and one carbon monoxide detector in
4	both the kitchen and sleeping quarters.
5	(vii) Installed in accordance with pre-engineered
6	and prefabricated assembly instructions.

8	Section 3. This act shall take effect in 60 days.
