1 2 3	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in other required equipment, providing for student driver sign.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Title 75 of the Pennsylvania Consolidated
7	Statutes is amended by adding a section to read:
8	<u>§ 4538. Student driver sign.</u>
9	(a) PlacementA student driver must place a student driver
10	sign on the rear of the vehicle that the student driver is
11	operating to alert other drivers that a student driver is
12	operating the vehicle.
13	(b) Duties of departmentThe department shall do all of
14	the following:
15	(1) Produce student driver signs as follows:
16	(i) Each student driver sign shall be magnetic.
17	<u>(ii) Each student driver sign for placement on a</u>
18	vehicle, except a motorcycle, shall be four inches in

1	height by 12 inches in length.
2	(iii) Each student driver sign for placement on a
3	motorcycle shall be four inches in height by four inches
4	<u>in length.</u>
5	(2) Issue student driver signs when a learner's permit
6	is issued to a student driver.
7	(3) Issue an instruction sheet for the use of the
8	student driver sign to the student driver informing the
9	student driver of the requirement of placing the student
10	driver sign on the rear of the vehicle that is operated by
11	the student driver.
12	(c) CostThe cost of a student driver sign shall be
13	determined by the department and must be paid by the student
14	driver at the same time as the payment of the fee for the
15	<u>learner's permit.</u>
16	(d) ReturnA student driver sign may be returned to the
17	department for reuse.
18	(e) DefinitionsAs used in this section, the following
19	words and phrases shall have the meanings given to them in this
20	subsection unless the context clearly indicates otherwise:
21	"Minor." A person under 21 years of age.
22	"Student driver." A minor with a valid learner's permit
23	issued under section 1505 (relating to learners' permits).
24	"Student driver sign." A sign produced by the department and
25	issued under this section.
26	Section 2. The addition of 75 Pa.C.S. § 4538 shall apply to
27	minors who are issued a learner's permit under 75 Pa.C.S. § 1505
28	on or after the effective date of this section.
29	Section 3. This act shall take effect in 60 days.
