1 2 3 4 5 6 7	Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public welfare laws of the Commonwealth," in public assistance, further providing for responsibilities and obligations of the Department of Human Services, applicants and recipients and establishing the Electronic Benefits Transfer Card Management Program.
8	The General Assembly of the Commonwealth of Pennsylvania
9	hereby enacts as follows:
10	Section 1. Section 405.3(a) of the act of June 13, 1967
11	(P.L.31, No.21), known as the Human Services Code, is amended by
12	adding a paragraph to read:
13	Section 405.3. Responsibilities and Obligations of
14	Department, Applicants and Recipients(a) Subject to Federal
15	approval, only where necessary, each adult applicant or
16	recipient of cash assistance or other person who is required to
17	sign an application for assistance shall be required as a
18	condition of eligibility to enter into a mutual agreement with
19	the department that will set forth the responsibilities and
20	obligations to be undertaken by the recipient to achieve self-

sufficiency, the time frames within which each obligation is to 1 2 be completed, the penalties for failure to comply and the 3 actions to be taken by the department to support the efforts of the applicant or recipient. Where appropriate, these obligations 4 shall include, but not be limited to: 5 * * * 6 7 (10) Agreeing to comply with the requirements of the 8 Electronic Benefits Transfer Card Management Program under 9 section 414.1. * * * 10 Section 2. The act is amended by adding a section to read: 11 12 Section 414.1. Electronic Benefits Transfer Card Management 13 Program. -- (a) The department shall establish and maintain a 14 program to be known as the Electronic Benefits Transfer Card 15 Management Program. 16 (b) The purpose of the program is to ensure the efficient delivery of public assistance through the proper management of 17 18 electronic benefits transfer cards. 19 (c) The department shall promulgate rules and regulations enumerating acceptable purchases and transaction types which are 20 consistent with assisting the recipient in achieving self-21 22 sufficiency. 23 (d) The department shall develop electronic controls, 24 oversight mechanisms and follow-up procedures to detect and 25 track the following: 26 (1) Suspicious electronic benefits transfer card transactions that might indicate fraudulent use. In order to 27 28 implement this paragraph, the department shall have the 29 fo<u>llowing duties:</u> (i) Collect information regarding the use of electronic 30

1	benefits transfer cards if more than fifty percent of the funds
2	used in the electronic benefits transfer card transactions occur
3	outside of this Commonwealth.
4	(ii) Differentiate between electronic benefits transfer card
5	transactions that occur in states that border this Commonwealth
6	and electronic benefits transfer card transactions that occur in
7	states that do not border this Commonwealth.
8	(iii) Analyze electronic benefits transfer card transactions
9	that occur outside of this Commonwealth to determine if the
10	recipient of benefits is a resident of this Commonwealth. In
11	making a determination under this subparagraph, the department
12	shall analyze the following:
13	(A) The location of employment of the recipient of benefits.
14	(B) The amount of times that the electronic benefits
15	transfer card is used outside of this Commonwealth compared to
16	the amount of times the electronic benefits transfer card is
17	used in this Commonwealth.
18	(C) Whether the electronic benefits transfer card
19	transactions occur in-person or through electronic means.
20	(2) The use of electronic benefits transfer cards that might
21	indicate an attempt to acquire goods and services that do not
22	comply with the rules and regulations promulgated under
23	subsection (c).
24	(e) Unless otherwise prohibited, data and information
25	gathered under this section shall be made available to the
26	Office of Inspector General, the Auditor General and the
27	Attorney General.
28	(f) As used in this section, the term "program" means the
29	Electronic Benefits Transfer Card Management Program.
30	Section 3. The addition of sections 405.3(a)(10) and 414.1
