AN ACT

- Establishing the COVID-19 Entertainment and Hospitality Grant
- Program to provide grants to entertainment venues and
- businesses within the hospitality industry that have been
- adversely impacted by the COVID-19 pandemic. 4
- The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the COVID-19
- Entertainment and Hospitality Grant Program Act.
- Section 2. Definitions. 10
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Applicant." An entertainment venue located in this
- 15 Commonwealth or an entity operating within the hospitality
- 16 industry in this Commonwealth that applies for assistance under
- 17 the program established in section 3.

- 1 "Bar." An establishment that primarily serves alcohol for
- 2 on-site consumption. The term includes a tavern or night club.
- 3 "Brewery." An establishment that produces or sells beer as
- 4 defined by section 5052(d) of the Internal Revenue Code of 1986
- 5 (Public Law 99-514, 26 U.S.C. § 5052(d)).
- 6 "COVID-19." The coronavirus disease 2019, an infectious
- 7 disease caused by severe acute respiratory syndrome coronavirus
- 8 2 that was first identified during December 2019 in Wuhan,
- 9 China.
- 10 "Department." The Department of Community and Economic
- 11 Development of the Commonwealth.
- 12 "Entertainment venue." An entity which derives its business
- 13 profits from providing entertainment to the public.
- 14 "Hospitality." An entity which provides at least one of the
- 15 following to individuals:
- 16 (1) Meals.
- 17 (2) Beverages.
- 18 (3) Recreation.
- 19 (4) Lodging.
- 20 "Hotel." A place of business located in this Commonwealth
- 21 having a North American Industry Classification System (NAICS)
- 22 designation from the United States Census Bureau within the
- 23 Accommodation subsector (721) and where accommodation is
- 24 provided for the public, with or without charge.
- 25 "Performing arts facility." Any of the following:
- 26 (1) Halls or theaters in which live musical, concert,
- dance, ballet and legitimate play book-length productions are
- performed that have seating for no more than 350 people.
- 29 (2) Small movie theaters that have permanent seating in
- 30 the facility for no more than 350 people.

- 1 "Proclamation of disaster emergency." The proclamation of
- 2 disaster emergency issued by the Governor on March 6, 2020,
- 3 published at 50 Pa.B. 1644 (March 21, 2020), and any renewal of
- 4 the state of disaster emergency.
- 5 "Program." The COVID-19 Entertainment and Hospitality Grant
- 6 Program established under section 3.
- 7 "Restaurant." A nonfranchise employer in this Commonwealth
- 8 that satisfies all of the following:
- 9 (1) The employer has a 72251, 72241, 722320 or 722330
- 10 NAICS designation from the United States Census Bureau.
- 11 (2) The employer's gross annual receipts for the prior
- fiscal year did not exceed \$1,000,000.
- 13 Section 3. Establishment and duties of department.
- 14 (a) Establishment. -- The program is established within the
- 15 department.
- 16 (b) Duties of department. -- The department shall provide
- 17 grants under the program in accordance with this act to
- 18 applicants that have been financially adversely affected by
- 19 COVID-19 or the proclamation of disaster emergency.
- 20 Section 4. Eligibility.
- 21 To be considered for a grant under the program, the applicant
- 22 must certify in good faith as the date of the application that
- 23 the applicant:
- 24 (1) Operates one location within this Commonwealth.
- 25 (2) Employs no more than 150 full-time equivalent
- 26 employees at the business location.
- 27 (3) Suffered a financial adverse economic impact due to
- COVID-19 or the proclamation of disaster emergency which
- 29 makes this grant request necessary to support the ongoing
- 30 operations of the business.

- 1 (4) Is an eligible entertainment venue or entity
- 2 operating in the hospitality industry in this Commonwealth,
- 3 including, but not limited to:
- 4 (i) Restaurant.
- 5 (ii) Bar, tavern or brewery.
- 6 (iii) Hotel or lodging facility.
- 7 (iv) Performing arts facility.
- 8 (v) Catering and catering supplies company.
- 9 Section 5. Application.
- 10 (a) Form. -- The department shall develop a grant application
- 11 form for applicants to apply for a grant under the program
- 12 established under section 3. At a minimum, the application form
- 13 shall contain the following information:
- 14 (1) The name, address and contact information of the
- 15 applicant.
- 16 (2) The amount of grant money requested.
- 17 (3) The proposed use of any grant money received from
- 18 the program.
- 19 (4) The financial impact on the business due to COVID-19
- or the proclamation of disaster emergency.
- 21 (5) Any other information that the department deems
- 22 necessary and appropriate.
- 23 (b) Submission. -- An applicant shall submit the application
- 24 to the department in a manner prescribed by the department to be
- 25 eligible for a grant under the program.
- 26 Section 6. Restrictions.
- 27 Grant money awarded shall only be used for business
- 28 operations, including, but not limited to:
- 29 (1) Payroll costs.
- 30 (2) Payment of interest on mortgage obligations, which

- 1 may not include any prepayment of or payment of principal on
- 2 a mortgage obligation.
- 3 (3) Payment on a rent obligation.
- 4 (4) Payment for utilities.
- 5 Section 7. Award of grants.
- 6 (a) Timing. -- No later 20 days after receipt of the grant
- 7 application form under section 5, the department shall:
- 8 (1) Review the grant application form.
- 9 (2) Determine whether to award a grant to the applicant.
- 10 (3) Determine the amount of the grant money to be
- awarded to the applicant, if applicable.
- 12 (b) Considerations. -- In determining the amount of the grant
- 13 money to be awarded to an applicant, the department shall
- 14 consider:
- 15 (1) The geographic and demographic diversity of the
- 16 business.
- 17 (2) How an applicant and the surrounding community in
- 18 which the applicant is located would be served through the
- award of the grant money to the applicant.
- 20 (c) Documentation. -- The department may require documentation
- 21 and information regarding the gross annual receipts and
- 22 information of employees of an applicant.
- 23 (d) Priority.--Priority in the awarding of grants shall be
- 24 given to applicants that have not received a loan or grant
- 25 issued under the authority of the Commonwealth or the
- 26 Commonwealth's political subdivisions for COVID-19 relief or by
- 27 the Federal government under the Coronavirus Aid, Relief, and
- 28 Economic Security Act (Public Law 116-136, 134 Stat. 281).
- 29 Section 8. Public notice.
- 30 The department shall provide information regarding the

- 1 availability and award of grants under the program on the
- 2 department's publicly accessible Internet website.
- 3 Section 9. Limitation.
- 4 Subject to the availability of funding, a grant to an
- 5 applicant under the program shall not exceed \$20,000. An
- 6 applicant may be deemed ineligible if the applicant previously
- 7 received more than \$100,000 in the form of a loan or grant for
- 8 COVID-19 relief from the Commonwealth.
- 9 Section 10. Reporting.
- 10 (a) Report.--No later than 60 days after notice is published
- 11 under section 8, the department shall prepare a report that
- 12 lists each applicant that received grant money under the program
- 13 and a summary of the information specified in each grant
- 14 application form.
- 15 (b) Publication. -- The department shall post the report
- 16 required under subsection (a) on the department's publicly
- 17 accessible Internet website.
- 18 Section 11. Guidelines.
- 19 The department may promulgate regulations and guidelines for
- 20 the implementation and administration of this act.
- 21 Section 12. Appropriation.
- The sum of \$145,000,000 shall be transferred from the
- 23 Workers' Compensation Security Fund into the General Fund and
- 24 \$55,000,000 shall be transferred from the Budget Stabilization
- 25 Reserve Fund into the General Fund for the purpose of awarding
- 26 grants under this act.
- 27 Section 13. Allocation.
- The department shall allocate a minimum of \$200,000,000 for
- 29 the purpose of awarding grants under this program. The
- 30 department shall reserve \$100,000,000 of the funds received for

- 1 entertainment venues and \$100,000,000 for entities in the
- 2 hospitality industry.
- 3 Section 14. Effective date.
- 4 This act shall take effect immediately.
