## AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in school directors, providing for publication of e-mail addresses for school directors-; AND, 5 6 IN CHARTER SCHOOLS, PROVIDING FOR PUBLICATION OF E-MAIL 7 ADDRESSES FOR BOARD OF TRUSTEES AND FURTHER PROVIDING FOR APPLICABILITY OF OTHER PROVISIONS OF THIS ACT AND OF OTHER 9 ACTS AND REGULATIONS. 10 The General Assembly of the Commonwealth of Pennsylvania 11 12 hereby enacts as follows: 13 Section 1. The act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, is amended by adding  $\frac{1}{2}$ 14 15 section SECTIONS to read: <--Section 329. Publication of E-mail Addresses for School 16 17 Directors. -- Within one hundred eighty (180) days of the 18 effective date of this section, each school district shall 19 establish and publish on its publicly accessible Internet 20 website an e-mail address for each member of the board of school directors which may be used by members of the public, school 21

- 12 <u>SCHOOL STAFF AND STUDENTS TO COMMUNICATE WITH INDIVIDUAL BOARD</u>
- 13 MEMBERS REGARDING MATTERS OF CHARTER SCHOOL GOVERNANCE. SUCH E-
- 14 MAIL ADDRESSES SHALL BE PUBLISHED IN A LOCATION AND MANNER THAT
- 15 ARE EASILY VISIBLE AND ACCESSIBLE TO THE PUBLIC.
