AN ACT

Amending the act of April 9, 1929 (P.L.343, No.176), entitled 1 "An act relating to the finances of the State government; 2 providing for cancer control, prevention and research, for 3 ambulatory surgical center data collection, for the Joint 4 Underwriting Association, for entertainment business 5 financial management firms, for private dam financial 6 7 assurance and for reinstatement of item vetoes; providing for the settlement, assessment, collection, and lien of taxes, 8 bonus, and all other accounts due the Commonwealth, the 9 collection and recovery of fees and other money or property 10 due or belonging to the Commonwealth, or any agency thereof, 11 including escheated property and the proceeds of its sale, 12 the custody and disbursement or other disposition of funds 13 and securities belonging to or in the possession of the 14 Commonwealth, and the settlement of claims against the 15 Commonwealth, the resettlement of accounts and appeals to the 16 courts, refunds of moneys erroneously paid to the 17 Commonwealth, auditing the accounts of the Commonwealth and 18 19 all agencies thereof, of all public officers collecting 20 moneys payable to the Commonwealth, or any agency thereof, and all receipts of appropriations from the Commonwealth, 21 authorizing the Commonwealth to issue tax anticipation notes 22 23 to defray current expenses, implementing the provisions of 24 section 7(a) of Article VIII of the Constitution of 25 Pennsylvania authorizing and restricting the incurring of 26 certain debt and imposing penalties; affecting every 27 department, board, commission, and officer of the State government, every political subdivision of the State, and 28 certain officers of such subdivisions, every person, 29 association, and corporation required to pay, assess, or 30

8	The General Assembly of the Commonwealth of Pennsylvania
9	hereby enacts as follows:
10	Section 1. The act of April 9, 1929 (P.L.343, No.176), known
11	as The Fiscal Code, is amended by adding a section to read:
12	Section 143-C. Additional emergency education relief
13	to educational entities.
14	(a) DistributionsFrom money appropriated by the General
15	Assembly for distribution under this section, the following
16	shall apply:
17	(1) The amount available shall be distributed to
18	intermediate units as follows:
19	(i) Multiply the intermediate unit's 2020-2021
20	market value/income aid ratio by the intermediate unit's
21	2018-2019 average daily membership.
22	<u>(ii) Multiply the product under subparagraph (i)</u>
23	by the amount available for distribution under this
24	section.
25	(iii) Divide the product from subparagraph (ii) by
26	the sum of the products of the 2020-2021 market
27	value/income aid ratio multiplied by the 2018-2019
28	average daily membership for all intermediate units.
29	(2) (Reserved).
30	(b) DefinitionsAs used in this section, the term "average
31	daily membership" means the sum of the average daily membership
32	of an intermediate unit's component school districts.
33	Section 2. This act shall take effect immediately.
