AN ACT

- 1 Providing for unannounced inspections of certain facilities and 2 persons that provide child day care; conferring powers and
- duties on the Department of Human Services; and abrogating a
- 4 regulation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Unannounced
- 9 Inspection of Child Day-Care Facilities Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- "Child day care." Care in lieu of parental care provided for
- 15 part of a 24-hour day to a child under 16 years of age away from
- 16 the child's home. The term does not include care in lieu of
- 17 parental care provided to a child under 16 years of age in a

- 1 place of worship during religious services.
- 2 "Child day-care center." A premises in which child day care
- 3 is provided simultaneously for seven or more children who are
- 4 not relatives of the provider, regardless of which article of
- 5 the act of June 13, 1967 (P.L.31, No.21), known as the Human
- 6 Services Code, applies to the premises.
- 7 "Department." The Department of Human Services of the
- 8 Commonwealth.
- 9 "Facility." Any of the following:
- 10 (1) Child day-care center.
- 11 (2) Family day-care home.
- "Family day-care home." A home in which child care is
- 13 provided at any one time to four, five or six children who are
- 14 not relatives of the provider of the child day care and that is
- 15 required to be licensed under the act of June 13, 1967 (P.L.31,
- 16 No.21), known as the Human Services Code.
- 17 Section 3. Inspections.
- 18 (a) Authority. -- The department may enter and inspect a
- 19 facility with or without prior notice.
- 20 (b) Access. -- The department shall have free and full access
- 21 to the facility and the facility grounds, the children in the
- 22 facility, the records of the facility and the facility staff.
- 23 The department shall be given the opportunity to privately
- 24 interview children and staff.
- 25 (c) Frequency of inspections. -- For a child day-care center
- 26 and a family day-care home, in accordance with current
- 27 requirements for an annual inspection under the act of June 13,
- 28 1967 (P.L.31, No.21), known as the Human Services Code, the
- 29 department shall annually conduct at least one onsite,
- 30 unannounced inspection of each facility. This unannounced

- 1 inspection shall be sufficient to meet any existing requirement
- 2 for an annual announced or unannounced inspection. The
- 3 department shall conduct additional inspections as required to
- 4 verify corrections of violations.
- 5 (d) Inspections in response to complaints.--
- 6 (1) Within 24 hours, excluding days that the department
- 7 has determined the facility is not in operation, of the
- 8 receipt of a complaint from any person alleging an immediate
- 9 and serious risk to the health or safety of a child receiving
- 10 child day care at a facility, the department shall conduct an
- onsite, unannounced inspection of the facility. Complaints
- 12 prompting an inspection pursuant to this subsection shall
- include severe injury or death of a child receiving care at
- 14 the facility, allegations of child abuse or conditions or
- practices that create an immediate and serious risk to a
- 16 child.
- 17 (2) Except for those complaints under paragraph (1), the
- department shall determine the acceptable time frame in which
- complaints shall be investigated based upon the seriousness
- of the complaint.
- 21 (3) This subsection applies to all facilities, including
- those that are required to be licensed or supervised under
- 23 the Human Services Code, but which are not so licensed or
- 24 supervised.
- 25 (e) Report to General Assembly. -- The department shall submit
- 26 on an annual basis a report to the Public Health and Welfare
- 27 Committee of the Senate and the Health Committee of the House of
- 28 Representatives regarding the findings of the inspections
- 29 required by this section.
- 30 Section 4. Licensure of family day-care homes.

- 1 Notwithstanding any other provision of law, a family day-care
- 2 home shall be licensed under Article X of the act of June 13,
- 3 1967 (P.L.31, No.21), known as the Human Services Code.
- 4 Section 5. Abrogation.
- 5 The application, inspection and registration provisions under
- 6 55 Pa. Code § 3290.11 (relating to application for and issuance
- 7 of a certificate of registration) are abrogated insofar as they
- 8 are inconsistent with this act.
- 9 Section 6. Effective date.
- 10 This act shall take effect immediately.
