13	(i) Paragraph (2) applies whether or not parental
14	rights of the parent have been terminated due to a
15	conviction of the parent where a child was conceived as a
16	result of any of the following offenses:

17	(b.1) Parent convicted of certain sexual offenses The

20	to the contrary, no court shall award any type of custody set
21	forth in section 5323 (relating to award of custody) to the
22	parent of a child conceived as a result of any of the
23	following offenses for which the parent has been convicted:

- 10 Section 4. This act shall take effect in 60 days.
