## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in the State System of Higher
- 6 Education, providing for equalization of appropriations.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10  $\,$  as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 <u>Section 2022-A. Equalization of Appropriations.--(a) The</u>
- 13 <u>Secretary of the Budget shall annually calculate the difference</u>
- 14 <u>between the following:</u>
- 15 (1) The total amount appropriated to the system for
- 16 <u>education and general support.</u>
- 17 (2) The total amount appropriated to the State-related
- 18 <u>institutions for education and general support.</u>
- 19 (b) (1) If the total amount appropriated to the system for
- 20 education and general support is less than the total amount

- 1 appropriated to the State-related institutions for education and
- 2 general support, the Secretary of the Budget shall certify the
- 3 amount of the difference and transmit a notice of the amount to
- 4 the Legislative Reference Bureau for publication in the
- 5 <u>Pennsylvania Bulletin.</u>
- 6 (2) If any subsequent acts affect the certified amount
- 7 calculated under this subsection, the Secretary of the Budget
- 8 shall recertify the amount as may be necessary.
- 9 (c) Each fiscal year, if the total amount appropriated to
- 10 the system is less than the total amount appropriated to the
- 11 State-related institutions and a certified amount is published
- 12 <u>under subsection (b), the certified amount shall be transferred</u>
- 13 to the system.
- 14 (d) Any amounts required to be transferred to the system in
- 15 <u>accordance with this section are appropriated from the General</u>
- 16 Fund.
- 17 (e) The Secretary of the Budget shall determine the timing
- 18 and schedule of payments necessary to effectuate a transfer
- 19 required under this section over the course of a fiscal year.
- 20 (f) As used in this section, the following words and phrases
- 21 shall have the meanings given to them in this subsection unless
- 22 the context clearly indicates otherwise:
- "Education and general support" shall mean:
- 24 (1) Appropriations from the General Fund to a university or
- 25 a system of universities that support the education of
- 26 undergraduate and graduate students, or the operation of a
- 27 <u>university</u>, including funds used to provide any of the
- 28 following: instruction, research, public service, academic
- 29 <u>support</u>, <u>libraries</u>, <u>student services</u>, <u>institutional support</u>,
- 30 operation and maintenance of plants, scholarships and

- 1 <u>fellowships and debt service.</u>
- 2 (2) The term does not include appropriations for hospitals
- 3 affiliated with a university, agricultural extension offices and
- 4 <u>services</u>, <u>agriculture research or any grants provided by the</u>
- 5 <u>Pennsylvania Higher Education Assistance Agency to students</u>
- 6 <u>attending a university or any amount provided for capital</u>
- 7 projects financed through the issuance of general obligation
- 8 <u>debt</u>.
- 9 <u>"State-related institution" shall mean The Pennsylvania State</u>
- 10 University, the University of Pittsburgh, Temple University and
- 11 Lincoln University and their branch campuses.
- 12 Section 2. This act shall take effect July 1, 2023.
