- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 2702(a) of Title 30 of the Pennsylvania
- 7 Consolidated Statutes is amended and the section is amended by
- adding a subsection to read: 8
- § 2702. Nonresident and tourist licenses. 9
- 10 (a) Nonresident annual licenses. -- [For] Except as otherwise
- provided under subsection (a.1), for the purposes of this 11
- 12 chapter, any person who does not purchase a resident fishing
- license under section 2701 (relating to resident fishing 13
- 14 licenses) is eligible for a "Nonresident Annual Fishing License"
- 15 when the person:
- Has applied to an issuing agent or to the 16
- 17 commission.
- 18 Has paid the issuing agent or the commission a

2	(relating to license, permit and issuing agent fees).
3	(a.1) Nonresident full-time student annual licenses
4	(1) For the purposes of this chapter, any person who
5	does not purchase a resident fishing license under section
6	2701 is eligible for a "Nonresident Full-Time Student Annual
7	Fishing License" when the person:
8	(i) Is a nonresident and full-time student enrolled
9	at a high school, technical school, college or university
10	in this Commonwealth at least 30 days prior to submission
11	of the application under subparagraph (ii).
12	(ii) Has applied to an issuing agent or to the
13	commission and has provided a valid student
14	identification card or other written proof of the
15	<pre>enrollment.</pre>
16	(iii) Has paid the issuing agent or the commission a
17	license fee and issuing agent fee set forth in section
18	2715, the amount of which shall be equal to that paid by
19	a resident applying for the same type of license.
20	(2) The spouse or dependent of a person who obtains a
21	license under paragraph (1) may purchase the same license
22	when the spouse or dependent complies with paragraph (1)(ii)
23	and (iii).
24	(3) The license of a person who purchases a license
25	under this subsection shall be revoked if the person or the
26	<pre>person's spouse or parent:</pre>
27	(i) is no longer a nonresident and full-time student
28	enrolled at a high school, technical school, college or
29	university in this Commonwealth during the term of the
30	license; or

- 4 (4) Licenses under this subsection shall be issued on an
- 5 <u>annual basis, and the licenses under section 2717 (relating</u>
- 6 <u>to license and permit packaging options) shall not be made</u>
- 7 <u>available to persons who are eliqible to receive a license</u>
- 8 <u>under this subsection. A license may not be issued under this</u>
- 9 subsection using the Pennsylvania Automated Licensing Service
- 10 (PALS) or through other automated licensing venues,
- including, but not limited to, the Internet.

- 13 Section 2. This act shall apply to applications for licenses
- 14 submitted in any license year commencing after the effective
- 15 date of this section.
- 16 Section 3. This act shall take effect in 60 days.
