## AN ACT

- Amending the act of September 27, 1961 (P.L.1700, No.699),
- entitled "An act relating to the regulation of the practice
- of pharmacy, including the sales, use and distribution of drugs and devices at retail; and amending, revising,

- consolidating and repealing certain laws relating thereto," 5
- further providing for the authority to administer injectable
- 7 medications, biologicals and immunizations.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 10 Section 1. Section 9.2 of the act of September 27, 1961
- 11 (P.L.1700, No.699), known as the Pharmacy Act, added June 29,
- 12 2002 (P.L.673, No.102), is amended to read:
- 13 Section 9.2. Authority to Administer Injectable Medications,
- 14 Biologicals and Immunizations .-- (a) [Within eighteen months
- 15 from the effective date of this section, the] The board shall by
- 16 regulation establish education and training standards and
- 17 practice guidelines pursuant to which pharmacists shall be
- authorized to administer injectable medications, biologicals and 18

- 1 immunizations to [persons who are more than eighteen years of
- 2 age] <u>individuals seven years of age and older</u>. Such standards
- 3 and quidelines shall include, but not be limited to, the
- 4 following:
- 5 (1) Satisfactory completion of an academic and practical
- 6 curriculum approved by the board that includes the current
- 7 guidelines and recommendations of the Centers for Disease
- 8 Control and Prevention in the Public Health Service of the
- 9 United States Department of Health and Human Services, the
- 10 American Council on Pharmaceutical Education or a similar health
- 11 authority or professional body and includes, but is not limited
- 12 to, disease epidemiology, vaccine characteristics, injection
- 13 technique, emergency response to adverse events and related
- 14 topics.
- 15 (2) Maintenance of a current cardiopulmonary resuscitation
- 16 (CPR) certificate acceptable to the board.
- 17 (3) That the administration of injectable medications,
- 18 biologicals and immunizations be in accordance with a definitive
- 19 set of treatment guidelines established by a physician and
- 20 approved by the board.
- 21 (4) That a minimum of two hours of the thirty-hour
- 22 requirement for continuing education for license renewal be
- 23 dedicated to this area of practice.
- 24 (5) For individuals under eighteen years of age, that prior
- 25 parental consent must be obtained and that pharmacists are
- 26 <u>restricted to administering only immunizations. Administration</u>
- 27 of immunizations shall be in accordance with the immunization
- 28 <u>schedule established by the Centers for Disease Control and</u>
- 29 Prevention.
- 30 (6) Maintenance of a level of professional liability

- 1 <u>insurance coverage in the minimum amount of one million dollars</u>
- 2 (\$1,000,000) per occurrence or claim made. Failure to maintain
- 3 <u>insurance coverage as required shall subject the licensee to</u>
- 4 <u>disciplinary proceedings</u>. The board shall accept as satisfactory
- 5 <u>evidence of insurance coverage any of the following:</u>
- 6 (i) Personal purchased liability insurance.
- 7 (ii) Professional liability insurance coverage provided by
- 8 <u>the individual licensee's employer.</u>
- 9 <u>(iii) Similar insurance coverage acceptable to the board.</u>
- 10 (7) That notification by the pharmacist be provided to the
- 11 <u>individual's primary care provider, if known, within seventy-two</u>
- 12 <u>hours of administration</u>.
- 13 (b) [A] (1) Except as set forth in clause (2), a
- 14 pharmacist's authority to administer injectable medications,
- 15 biologicals and immunizations shall not be delegated to any
- 16 other person.
- 17 (2) A pharmacy intern who has completed a course of
- 18 education and training which meets the requirements of
- 19 <u>subsection (a)(1) and (2) may administer injectable medications,</u>
- 20 biologicals and immunizations only under the direct, immediate
- 21 and personal supervision of a pharmacist holding the authority
- 22 to administer injectable medications, biologicals and
- 23 immunizations.
- 24 Section 2. This act shall take effect in 60 days.
