AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, in National Guard Youth Challenge
- 3 Program, further providing for definitions and for
- 4 administration, establishing the Keystone State Challenge
- 5 Academy Fund and further providing for report and for audit
- 6 required.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 9801 of Title 51 of the Pennsylvania
- 10 Consolidated Statutes is amended by adding a definition to read:
- 11 § 9801. Definitions.
- 12 The following words and phrases when used in this chapter
- 13 shall have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Fund." The Keystone State Challenge Academy Fund
- 16 <u>established under section 9807 (relating to Keystone State</u>
- 17 Challenge Academy Fund).
- 18 * * *
- 19 Section 2. Sections 9806, 9807, 9810 and 9811 of Title 51

- 1 are amended to read:
- 2 § 9806. Administration.
- 3 (a) Staffing. -- Subject to 32 U.S.C. § 509 (relating to
- 4 National Guard Youth Challenge Program of opportunities for
- 5 civilian youth) and its implementing regulations and applicable
- 6 agreements, the program shall be staffed by the administrative,
- 7 professional, technical and clerical employees necessary for the
- 8 operation of the program.
- 9 (b) Statement of policy. -- The department shall adopt a
- 10 statement of policy for the maintenance and use of the fund
- 11 within 60 days of the effective date of this subsection. The
- 12 policy shall be transmitted as a notice to the Legislative
- 13 Reference Bureau for publication in the Pennsylvania Bulletin
- 14 but shall not be subject to review under section 205 of the act
- 15 of July 31, 1968 (P.L.769, No.240), referred to as the
- 16 Commonwealth Documents Law, sections 204(b) and 301(10) of the
- 17 <u>act of October 15, 1980 (P.L.950, No.164), known as the</u>
- 18 Commonwealth Attorneys Act, or the act of June 25, 1982
- 19 (P.L.633, No.181), known as the Regulatory Review Act.
- 20 § 9807. [Funding.] <u>Keystone State Challenge Academy Fund.</u>
- 21 (a) Establishment. -- The Keystone State Challenge Academy
- 22 Fund is established as a special fund in the State Treasury.
- 23 (b) Appropriation.--All money deposited into the fund and
- 24 the interest the fund accrues are appropriated to the department
- 25 on a continuing basis to be used for the purposes provided under
- 26 this chapter.
- 27 <u>(c) Use of fund.--The fund may only be used for the purposes</u>
- 28 provided for under this chapter and no money in the fund may be
- 29 transferred or diverted to any other purpose by administrative
- 30 action.

- 1 (d) Sources of money. -- Money available to the fund shall
- 2 <u>include appropriations and transfers from the General Fund</u>,
- 3 special funds, Federal funds and other sources of revenue made
- 4 available to the fund.
- 5 (e) Allocation. -- Money from the fund shall be allocated for
- 6 the purposes provided for under this chapter no later than
- 7 October 31, 2021, and each October 31 thereafter.
- 8 <u>(f) Funding.--</u>The department shall apply for funding, as
- 9 provided for under 32 U.S.C. § 509(d) (relating to National
- 10 Guard Youth Challenge Program of opportunities for civilian
- 11 youth). Under 32 U.S.C. § 509(j), the department may supplement
- 12 such funding with other resources, including gifts, made
- 13 available to the department and may also accept, use and dispose
- 14 of gifts or donations of money, other property or services for
- 15 the program.
- 16 § 9810. Report.
- [The department shall submit annually to] By July 31,
- 18 SEPTEMBER 30, 2021, and each July 31 SEPTEMBER 30 thereafter, <--

- 19 the department shall submit to the chairperson and minority
- 20 chairperson of the Appropriations Committee of the Senate, the
- 21 chairperson and minority chairperson of the Education Committee
- 22 of the Senate, the chairperson and minority chairperson of the
- 23 Veterans Affairs and Emergency Preparedness Committee of the
- 24 Senate, the chairperson and minority chairperson of the
- 25 Appropriations Committee of the House of Representatives, the
- 26 chairperson and minority chairperson of the Education Committee
- 27 of the House of Representatives and the chairperson and minority
- 28 chairperson of the Veterans Affairs and Emergency Preparedness
- 29 Committee of the House of Representatives a written report
- 30 concerning the program. The report shall include, but not be

- 1 limited to, all of the following:
- 2 (1) The number of individuals who applied to the program
- 3 in the previous fiscal year.
- 4 (2) The number of individuals who participated in the
- 5 program in the previous fiscal year.
- 6 (3) The number and percentage of program participants in 7 the previous fiscal year who achieved each of the following:
 - (i) Earned a high school diploma or its equivalent.
- 9 (ii) Enrolled in a course of study at an institution 10 of higher education.
- 11 (iii) Accepted a position of full-time, paid 12 employment.
- 13 (iv) Accepted a position of part-time, paid 14 employment.
- 15 (v) Entered the armed forces of the United States, 16 including a reserve component or the National Guard.
- 17 (4) The demographic makeup of the applicants to, and
 18 participants in, the program, including, but not limited to,
 19 the following:
- 20 (i) Race.

- 21 (ii) Age.
- 22 (iii) Gender.
- 23 (4.1) Details on the revenues and expenditures of the
- fund in the prior fiscal year and the identification and
- description of activities, programs and projects which
- 26 received money from the fund.
- 27 (5) Any information the department provides to the
- Secretary of Defense under 32 U.S.C. § 509(k) (relating to
- 29 National Guard Youth Challenge Program of opportunities for
- 30 civilian youth).

- 1 § 9811. Audit required.
- 2 The department shall undergo an annual audit of the program.
- 3 The audit shall be conducted AS PART OF THE COMMONWEALTH'S

- 4 <u>SINGLE AUDIT</u> by a qualified [independent] certified public
- 5 accountant under generally accepted audit standards of the
- 6 Governmental Accounting Standards Board. The audit shall be
- 7 submitted to the following:
- 8 (1) The chairperson and minority chairperson of the
- 9 [Education] <u>Appropriations</u> Committee of the Senate.
- 10 (1.1) The chairperson and minority chairperson of the
- 11 Education Committee of the Senate.
- 12 (2) The chairperson and minority chairperson of the
- 13 Veterans Affairs and Emergency Preparedness Committee of the
- 14 Senate.
- 15 (2.1) The chairperson and minority chairperson of the
- 16 Appropriations Committee of the House of Representatives.
- 17 (3) The chairperson and minority chairperson of the
- 18 Education Committee of the House of Representatives.
- 19 (4) The chairperson and minority chairperson of the
- 20 Veterans Affairs and Emergency Preparedness Committee of the
- 21 House of Representatives.
- 22 Section 3. This act shall take effect immediately.
