AN ACT

Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying and enumerating certain subjects of taxation and imposing 3 taxes thereon; providing procedures for the payment, collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and imposing duties upon the Department of Revenue, certain 7 employers, fiduciaries, individuals, persons, corporations 8 and other entities; prescribing crimes, offenses and 9 penalties," in personal income tax, further providing for 10 classes of income. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. Section 303 of the act of March 4, 1971 (P.L.6, 15 No.2), known as the Tax Reform Code of 1971, is amended by 16 adding a subsection to read: 17 Section 303. Classes of Income. -- * * * 18 (a.11) A person may claim a deduction for depletion of a mine, oil and gas well and other natural deposit in accordance 20 with 26 U.S.C. Ch. 1 Subch. I Pt. I (relating to deductions) in effect on the effective date of this subsection. 21 22 * * *

- 1 Section 2. The addition of section 303(a.11) of the act
- 2 shall apply to tax years beginning after December 31, 2021.
- 3 Section 3. This act shall take effect immediately.
