## AN ACT

- Amending the act of January 28, 1988 (P.L.24, No.11), entitled "An act defining and providing for the licensing and 2 regulation of private academic schools; reestablishing the 3 State Board of Private Academic Schools; imposing penalties; and making repeals," further providing for definitions, for State Board of Private Academic Schools, for powers and 6 duties of board, for application for license, for issuance 7 and renewal of license, for directory of private academic 8 schools, for requirements for licensure and operation, for 9 enforcement, refusal, suspension or revocation of license and 10 for promulgation of rules and regulations. 11 The General Assembly of the Commonwealth of Pennsylvania

- 13 hereby enacts as follows:
- 14 Section 1. Sections 2, 3(c) and (g), 4(b) and (c), 7(a) and
- 15 (b), 8(a) and (b), 11, 12(a), 13(b)(4) and 14 of the act of
- January 28, 1988 (P.L.24, No.11), known as the Private Academic 16
- 17 Schools Act, are amended to read:
- Section 2. Definitions. 18
- 19 The following words and phrases when used in this act shall
- 20 have the meanings given to them in this section unless the
- 21 context clearly indicates otherwise:
- 22 "Annual." Twelve months from the date of initial licensure.

- 1 "Board." The State Board of Private Academic Schools.
- 2 "Department." The Department of Education of the
- 3 Commonwealth.
- 4 <u>"Office." The Office of Elementary and Secondary Education</u>
- 5 within the Department of Education of the Commonwealth.
- 6 <u>"Online school." A school with at least one office located</u>
- 7 in this Commonwealth which uses technology in order to provide a
- 8 <u>significant portion of its curriculum and to deliver a</u>
- 9 significant portion of instruction to its students through the
- 10 Internet or other electronic means and which shall not include a
- 11 cyber charter school as provided under Article XVII-A of the act
- 12 of March 10, 1949 (P.L.30, No.14), known as the Public School
- 13 Code of 1949.
- 14 "Premises." Any grounds or facilities utilized by a school
- 15 for the purposes of providing instruction or in the case of an
- 16 <u>online school any office space or facilities from which</u>
- 17 instruction will be transmitted or from which administrative
- 18 support is offered.
- 19 "Private academic school" or "school." A school maintained,
- 20 or classes conducted, for the purpose of offering instruction
- 21 for a consideration, profit or tuition to five or more pupils at
- 22 one and the same time, or to 25 or more pupils during any school
- 23 year, the purpose of which is to educate an individual generally
- 24 or specially or to prepare an individual for more advanced
- 25 study, and shall include all schools engaged in such education,
- 26 including online schools, except private trade schools, private
- 27 business schools, private correspondence schools, private music
- 28 schools, private dance schools, private art schools, private
- 29 dramatic art schools, private schools of charm or poise, private
- 30 driver training schools or any type of private school which is

- 1 nonacademic in character.
- 2 "Secretary." The Secretary of Education of the Commonwealth.
- 3 Section 3. State Board of Private Academic Schools.
- 4 \* \* \*
- 5 (c) Administrative support.--Administrative support for the
- 6 board shall be provided by the [department] office in accordance
- 7 with section 214 of the act of April 9, 1929 (P.L.177, No.175),
- 8 known as The Administrative Code of 1929. The [department]
- 9 <u>office</u> shall periodically consult with the board regarding its
- 10 administrative needs.
- 11 \* \* \*
- 12 (g) Documents. -- Certificates of licensure and other official
- 13 documents approved by the board shall be issued by the
- 14 [department] office.
- 15 Section 4. Powers and duties of board.
- 16 \* \* \*
- 17 (b) Disposition of student records. -- The board shall require
- 18 every applicant for initial licensure to provide a written
- 19 statement describing arrangements for disposition of student
- 20 records in the event of closure. It shall be the duty of the
- 21 board and the [department] office to assist in the execution of
- 22 the arrangements when necessary.
- 23 (c) Enforcement by [department] office. -- The regulations
- 24 promulgated by the board shall be enforced by the [department]
- 25 <u>office</u>. The [department] <u>office</u> may submit to individual experts
- 26 for review, programs and courses and financial statements
- 27 proposed or offered by a school.
- 28 Section 7. Application for license.
- 29 (a) General rule. -- Before any license is issued to a private
- 30 academic school, a verified application shall be made, in

- 1 writing, to the board on a form prepared and furnished by the
- 2 [department] office.
- 3 (b) Application contents. -- The application shall require a 4 statement showing:
- 5 (1) The title or name and address of the school <u>or, in</u>
- 6 the case of an online school, the school offices, grades and
- 7 classes, together with the name of the owners and controlling
- 8 officers.
- 9 (2) The specific fields of instruction which will be
- offered and the purposes of such instruction.
- 11 (3) [The] <u>Any</u> place where instruction will be given[.]
- or, in the case of an online school, from which instruction
- will be transmitted or from which administrative support is
- offered.
- 15 (4) A specific listing of the equipment and
- instructional materials available for instruction in the
- 17 school.
- 18 (5) The maximum enrollment to be accommodated at the
- 19 school.
- 20 (6) The qualifications of teachers, professional staff
- 21 and director.
- 22 (7) Financial resources available to equip and maintain
- the school.
- 24 (8) An agreement to abide by reasonable service and
- business ethics prescribed by the board.
- 26 (9) Any additional information the board may deem
- 27 necessary to enable it to determine the adequacy of the
- 28 program of instruction and related matters.
- 29 An application must be completed for board consideration.
- 30 \* \* \*

- 1 Section 8. Issuance and renewal of license.
- 2 (a) General rule. -- The [department] office shall issue an
- 3 original license to the applicant if the board finds that the
- 4 application and the school for which a license is sought comply
- 5 with the provisions of this act and with the rules and
- 6 regulations promulgated under this act.
- 7 (b) Duration and renewal. -- Each original school license
- 8 issued shall be effective from the date of issue until the same
- 9 date of the month of original issue the following year and shall
- 10 be renewed annually thereafter on a form prepared and furnished
- 11 by the [department] office.

- 13 Section 11. Directory of private academic schools.
- 14 The [department] office shall maintain a list of private
- 15 academic schools which shall be available to the public.
- 16 Section 12. Requirements for licensure and operation.
- 17 (a) Inspection. -- No private academic school may be granted a
- 18 license or permitted to continue to operate under a granted
- 19 license unless it permits the board and its representatives to
- 20 inspect the school or classes or, in the case of an online
- 21 school, any office space or facility from which instruction will
- 22 be transmitted or from which administrative support is offered
- 23 and makes available to the board, at any time when requested to
- 24 do so, full information pertaining to the operation of the
- 25 school.

- 27 Section 13. Enforcement, refusal, suspension or revocation of
- license.
- 29 \* \* \*
- 30 (b) Refusal to issue, suspension of and revocation of

- 1 license. -- The board shall have the power to refuse to issue,
- 2 suspend or revoke a license if it finds that:
- 3 \* \* \*
- The applicant or licensee has failed or refused to 4 5 permit the board or its representatives to inspect the school 6 or classes or, in the case of an online school, any office 7 space or facility from which instruction will be transmitted 8 or from which administrative support is offered or has failed 9 or refused to make available to the board, at any time when 10 requested to do so, full information pertaining to any or all 11 items of information contained in an application for license 12 or pertaining to the operation of the private academic

- 15 Section 14. Promulgation of rules and regulations.
- 16 (a) General rule. -- The board shall promulgate rules and
- 17 regulations necessary to carry out the purposes of this act. The
- 18 rules and regulations of the State Board of Private Academic
- 19 Schools in force on the effective date of this act, and not
- 20 countermanded by this act, shall remain in effect until repealed
- 21 or amended by the board, but not for a period of more than one
- 22 year.
- 23 <u>(b) Online schools.--</u>
- 24 (1) The board shall promulgate rules and regulations and
- 25 <u>establish policies, principles and standards necessary to</u>
- 26 carry out the purposes of this act as they relate to online
- 27 <u>schools and which:</u>
- 28 <u>(i) address the unique provision of instruction and</u>
- 29 <u>services to students by online schools; and</u>
- 30 (ii) provide for any additional requirements or

1	exemptions as may be required to accommodate the ability
2	of online schools to provide instruction and student
3	services.
4	(2) The rules, regulations, policies, principles and
5	standards shall take effect within 18 months of the effective
6	date of this subsection.
7	(3) Notwithstanding any other provision of this act to
8	the contrary, the board may not issue a license to an online
9	school until the rules and regulations, policies, principles
10	and standards required by paragraph (1) are in effect.
11	Section 2. This act shall take effect in 60 days.
