- 6 § 7401. Storm water management systems authorized.
- 7 The town council may plan, design, construct, assemble,
- 8 install and alter facilities, including, but not limited to,
- 9 <u>inlets</u>, <u>outlets</u>, <u>systems</u> of <u>piping</u>, <u>diversion</u> terraces, <u>grass</u>
- 10 waterways, energy dissipaters, storm water retention devices and
- 11 <u>natural or artificial infiltration areas, to manage surface</u>
- 12 <u>water runoff</u>.
- 13 § 7402. Construction of storm water management facilities.
- 14 (a) General rule. -- The town council may acquire by purchase,
- 15 deed of dedication or eminent domain proceedings all or part of
- 16 any existing system or facility for the management of surface
- 17 water runoff which may have been established or constructed by
- 18 any property owner in the incorporated town or establish,
- 19 construct and maintain systems or facilities in the best
- 20 interest of the incorporated town.
- 21 (b) Price.--If the town council and the owners of systems
- 22 can agree upon a price to be paid by the incorporated town, the
- 23 purchase may be consummated if the amount to be paid does not
- 24 exceed the actual value of the facilities to be transferred.
- 25 (c) Eminent domain. -- If the town council acquires the system
- 26 by the exercise of eminent domain, the damages shall be
- 27 determined by viewers under this act for eminent domain
- 28 proceedings.
- 29 § 7403. System management.
- 30 (a) General rule. -- When exercising the powers under this

- 1 chapter, the town council shall manage storm water originating
- 2 <u>in or passing through the incorporated town in a manner which is</u>
- 3 consistent with the requirements of the act of October 4, 1978
- 4 (P.L.864, No.167), known as the Storm Water Management Act, and
- 5 the storm water management quidelines and any regulations which
- 6 may be adopted by the Department of Environmental Protection.
- 7 (b) Consistency. -- All storm water management activities
- 8 <u>undertaken must be consistent with any watershed storm water</u>
- 9 management plan when the plan has been approved by the
- 10 Department of Environmental Protection.
- 11 (c) Review by county conservation district. -- When storm
- 12 <u>water management activities are undertaken in watersheds for</u>
- 13 <u>which there is no approved storm water management plan, all</u>
- 14 drawings, documents, profiles and designs and descriptions of
- 15 the proposed activities to be undertaken by the incorporated
- 16 town shall be submitted to the county conservation district for
- 17 review and comment before the initiation of earthmoving
- 18 <u>activities. The conservation district shall have 30 days to</u>
- 19 review and respond with comments to the board of commissioners.
- 20 Failure to respond within that time constitutes favorable
- 21 comment by the conservation district.
- 22 § 7404. Ordinances.
- 23 (a) Storm water management. -- The town council may enact
- 24 storm water management ordinances and require persons conducting
- 25 <u>earthmoving activities to obtain approval from the board of</u>
- 26 commissioners for those activities. Ordinances must be
- 27 <u>consistent with watershed storm water management plans where</u>
- 28 they exist and in all cases must be consistent with the act of
- 29 October 4, 1978 (P.L.864, No.167), known as the Storm Water
- 30 Management Act.

- 1 (b) Storm water facilities. -- The town council may enact and
- 2 <u>enforce ordinances to govern and regulate the planning</u>,
- 3 management, implementation, construction and maintenance of
- 4 <u>storm water facilities.</u>
- 5 § 7405. Fees.
- 6 (a) General rule. -- For the purposes of funding the
- 7 construction, maintenance and operation of storm water
- 8 management facilities, systems and plans authorized under this
- 9 <u>chapter</u>, an incorporated town may assess reasonable and uniform
- 10 fees based in whole or in part on the characteristics of the
- 11 property benefited by the facilities, systems and plans. In
- 12 <u>establishing the fees, the incorporated town may SHALL consider</u> <--
- 13 <u>and provide appropriate exemptions or credits for properties</u>
- 14 which have installed and are maintaining storm water facilities
- 15 that meet best management practices and are approved or
- 16 inspected by the incorporated town.
- 17 (b) Methods of assessments. -- Any fee levied by the
- 18 incorporated town can be assessed in one of the following
- 19 methods:
- 20 (1) On all properties in the incorporated town.
- 21 (2) On all properties benefited by a specific storm
- 22 water project.
- 23 (3) By establishing a storm water management district
- and assessing the fee on all property owners in the district.
- 25 (c) Use.--Any fee collected for the purposes of storm water
- 26 management may only be used for the purposes authorized by this
- 27 chapter.
- 28 (d) Filing.--The assessments shall be filed with the town
- 29 treasurer.
- 30 (e) Payments. -- An ordinance shall specify whether payments

- 1 are to be made by annual or more frequent installments.
- 2 Section 2. This act shall take effect in 60 days.
