AN ACT

- 1 Amending Title 8 (Boroughs and Incorporated Towns) of the
- 2 Pennsylvania Consolidated Statutes, in storm sewers and
- watercourses, further providing for authority of boroughs and
- for manner of financing work.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 2201 of Title 8 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding a subsection to read:
- 9 § 2201. Authority of boroughs.
- 10 * * *
- 11 (c) Ordinances. -- A borough may enact and enforce ordinances
- 12 to govern and regulate the planning, management, implementation,
- 13 construction and maintenance of storm water facilities.
- 14 Section 2. Section 2003 of Title 8 is amended to read:
- 15 § 2203. Manner of financing [work].
- 16 (a) General rule. -- A borough may pay for the costs and
- 17 expenses of any work or activity authorized under section 2201
- 18 (relating to authority of boroughs) wholly or in part from money
- 19 of the borough available for the purpose.

- 1 (b) Assessments. -- To the extent that a borough does not
- 2 receive assistance from the Federal, State or county government
- 3 for the costs and expenses of the work, the borough may assess
- 4 the benefited properties located within the drainage area of the
- 5 watercourse in accordance with Chapter 21A (relating to
- 6 assessments and charges for public improvements).
- 7 (c) Fees.--For the purposes of funding the construction,
- 8 maintenance and operation of storm water management facilities,
- 9 systems and management plans authorized under this chapter, a
- 10 borough may assess reasonable and uniform fees based in whole or
- 11 <u>in part on the characteristics of the property benefited by the</u>
- 12 facilities, systems and management plans. In establishing the
- 13 fees the borough may consider and provide appropriate exemptions
- 14 or credits for properties which have installed and are
- 15 <u>maintaining storm water facilities that meet best management</u>
- 16 practices and are approved or inspected by the borough. The
- 17 assessed fees shall be filed with the borough treasurer. An
- 18 ordinance shall specify whether payments are to be made by
- 19 annual or more frequent installments.
- 20 (d) Methods of assessment. -- Any fee levied by the borough
- 21 can be assessed in one of the following methods:
- 22 (1) On all properties in the borough.
- 23 (2) On all properties benefited by a specific storm
- 24 water project.
- 25 (3) By establishing a storm water management district
- and assessing the fee on all property owners in the district.
- 27 (e) Use.--Any fee collected for the purposes of storm water
- 28 management may only be used for the purposes authorized by this
- 29 chapter.
- 30 Section 3. This act shall take effect in 60 days.
