#### AN ACT

YODER HIGHWAY; DESIGNATING A CERTAIN INTERCHANGE IN GREENE COUNTY AS THE SERGEANT MICHAEL TODD MAY, MONONGALIA COUNTY SHERIFF'S DEPARTMENT, WEST VIRGINIA, INTERCHANGE; AND DESIGNATING THE MURTLAND AVENUE EXIT FROM INTERSTATES 79 AND 70 ONTO STATE ROUTE 19 IN WASHINGTON, WASHINGTON COUNTY, AS THE LANCE CORPORAL RYAN J. KOVACICEK, USMC, EXIT.
13	The General Assembly of the Commonwealth of Pennsylvania
14	hereby enacts as follows:
15	Section 1. AMVETS Memorial Bridge.
16	(a) Declaration of policyThe General Assembly finds and
17	declares as follows:
18	(1) The North Braddock AMVETS Post 60 was granted a
19	national charter by an act of Congress in February of 1946.
20	(2) Throughout the years, AMVETS Post 60 has been
21	actively involved in and around the local community. AMVETS
22	Post 60 was a cosponsor of the annual community Memorial Day

parade, which started in the late 1940's and lasted until the early 1970's. Local fire departments, marching bands and Boy Scouts and Girl Scouts participated in the parade.

4 (3) AMVETS Post 60 helped sponsor the local little
5 league, pony league and Boy Scouts and supported the local
6 volunteer fire departments, EMS services and police
7 departments.

8 (4) In the late 1970's AMVETS Post 60 took the lead in 9 restarting Memorial Day observances with other veterans' 10 organizations, and for the past 26 years has watched 11 community involvement grow.

12 (5) Since November of 2008, AMVETS Post 60 has been
13 holding a Veterans Day flag burning memorial service where
14 American Flags are properly disposed of.

15 (6) AMVETS Post 60 in North Braddock continues to serve 16 veterans and its community by offering a helping hand when 17 the need arises.

(b) Designation.--The bridges that carry Lincoln Highway
over Electric Avenue, in North Braddock Borough, Allegheny
County, State Bridge No. 02 0030 0230 0001 and State Bridge No.
02 0030 0231 0000, are each hereby designated the AMVETS
Memorial Bridge.

(c) Signs.--The Department of Transportation shall erect and maintain appropriate signs displaying the name of the bridges to traffic in both directions on the bridges.

1 1986. HE WAS A 2005 GRADUATE OF OLEY VALLEY HIGH SCHOOL, 2 WHERE HE WAS AN ACCOMPLISHED ATHLETE IN MULTIPLE SPORTS. UPON 3 GRADUATING, HE ENLISTED IN THE PENNSYLVANIA NATIONAL GUARD 4 AND WAS DEPLOYED TO THE REPUBLIC OF IRAQ AS PART OF OPERATION 5 IRAQI FREEDOM IN 2008 AS A MEMBER OF C COMPANY, 1-111TH 6 INFANTRY REGIMENT, 56TH STRYKER BRIGADE. AFTER HIS RETURN IN 7 2012, JARETT REALIZED HIS LIFELONG DREAM BY EARNING HIS WINGS 8 AT ARMY AVIATION SCHOOL.

9 (2) CHIEF WARRANT OFFICER 2 YODER WAS KILLED ON APRIL 9, 10 2013, IN NANGARHAR PROVINCE, ISLAMIC REPUBLIC OF AFGHANISTAN, 11 WHEN THE AH-64 APACHE HELICOPTER HE COPILOTED CRASHED FROM AN 12 UNDETERMINED CAUSE DURING AN AERIAL RECONNAISSANCE WHILE HE 13 WAS DEPLOYED WITH BRAVO COMPANY, 1-104TH ATTACK 14 RECONNAISSANCE BATTALION, PENNSYLVANIA ARMY NATIONAL GUARD AS 15 PART OF OPERATION ENDURING FREEDOM.

16 (3) CHIEF WARRANT OFFICER 2 YODER WAS POSTHUMOUSLY
17 AWARDED THE BRONZE STAR MEDAL, AIR MEDAL AND NATO MEDAL FOR
18 HIS SERVICE IN AFGHANISTAN. IN ADDITION, HE WAS AWARDED THE
19 COMBAT INFANTRYMAN BADGE, COMBAT ACTION BADGE, THE
20 AFGHANISTAN CAMPAIGN MEDAL WITH ONE BRONZE STAR AND THE IRAQ
21 CAMPAIGN MEDAL WITH ONE BRONZE STAR.

(4) CHIEF WARRANT OFFICER 2 YODER, THE HUSBAND OF
HEATHER L. GARAY-YODER, WHOM HE MARRIED SHORTLY BEFORE HIS
DEPLOYMENT TO AFGHANISTAN, AND THE SON OF DIANE C. AND GARY
L. YODER, DEMONSTRATED HIS COURAGEOUS COMMITMENT TO FAMILY
AND COUNTRY AT THE TIME OF HIS DEATH.

2 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
3 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE HIGHWAY TO

13 (2) SGT. MAY WAS KILLED WHILE INVOLVED IN A VEHICLE
14 PURSUIT THAT HAD CROSSED OVER THE WEST VIRGINIA/PENNSYLVANIA
15 STATE LINE.

16 (3) THE DRIVER OF THE VEHICLE RAMMED SGT. MAY'S PATROL
17 CAR AS HE WAITED IN THE MEDIAN FOR THE PURSUIT TO REACH HIS
18 LOCATION.

19 (4) THE DRIVER WAS CONVICTED OF THIRD DEGREE MURDER,
20 HOMICIDE BY VEHICLE, HOMICIDE BY VEHICLE WHILE DRIVING UNDER
21 THE INFLUENCE AND MULTIPLE OTHER COUNTS.

22 (5) SGT. MAY WAS BORN IN MORGANTOWN, WEST VIRGINIA, ON
23 APRIL 2, 1970.

24 (6) SGT. MAY WAS A 1988 GRADUATE OF MORGANTOWN HIGH
25 SCHOOL AND ATTENDED FAIRMONT STATE UNIVERSITY, WHERE HE
26 PURSUED A DEGREE IN CRIMINAL JUSTICE.

27 (7) AFTER COLLEGE, SGT. MAY GRADUATED FROM THE WEST
28 VIRGINIA STATE POLICE ACADEMY.

29 (8) SGT. MAY WAS EMPLOYED FOR A SHORT TIME WITH THE
 30 BERKELEY COUNTY SHERIFF'S DEPARTMENT AND THEN BEGAN HIS

CAREER WITH THE MONONGALIA COUNTY SHERIFF'S DEPARTMENT, WHERE
 HE WAS A LEAD ON THE SWAT TEAM.

3 (9) SGT. MAY ALSO WORKED AT THE EASTERN REGIONAL
4 CORRECTIONS FACILITY AND WAS A MEMBER OF THE TAU KAPPA
5 EPSILON FRATERNITY.

6 (10) MOREOVER, SGT. MAY SERVED AS PRESIDENT OF THE
7 MONONGALIA COUNTY SHERIFF'S ASSOCIATION.

8 (11) SGT. MAY IS SURVIVED BY HIS WIFE, RENEE; HIS 9 PARENTS, FRANKLIN AND CATHERINE MAY; HIS BROTHER, FRANKIE 10 MAY; HIS NIECE AND NEPHEW, CANON AND BRYIAR MAY; HIS AUNTS 11 AND UNCLES; AND SEVERAL COUSINS.

12 (B) DESIGNATION.--THE INTERCHANGE OF INTERSTATE 79 AT MOUNT 13 MORRIS IN GREENE COUNTY IS HEREBY DESIGNATED THE SGT. MICHAEL 14 TODD MAY, MONONGALIA COUNTY SHERIFF'S DEPARTMENT, WEST VIRGINIA, 15 INTERCHANGE.

16 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL INSTALL,
17 WHERE IT DEEMS FEASIBLE, THE APPROPRIATE MARKERS DESIGNATING
18 THIS INTERCHANGE AS THE SGT. MICHAEL TODD MAY, MONONGALIA COUNTY
19 SHERIFF'S DEPARTMENT, WEST VIRGINIA, INTERCHANGE.

6 MAINTAIN APPROPRIATE SIGNS TO INDICATE THE DESIGNATION UNDER
