1 2 3 4 5 6	Amending Title 44 (Law and Justice) of the Pennsylvania Consolidated Statutes, imposing a fee for service on municipalities for municipal patrol services provided by the Pennsylvania State Police and providing for State Police patrol services agreements, for allocation of funds, for fees for intermunicipal police response and for penalties.
7	The General Assembly of the Commonwealth of Pennsylvania
8	hereby enacts as follows:
9	Section 1. Title 44 of the Pennsylvania Consolidated

- 8 This chapter relates to municipal patrol services.
- 9 <u>§ 2502. Definitions.</u>
- 10 The following words and phrases when used in this chapter
- 11 shall have the meanings given to them in this section unless the
- 12 <u>context clearly indicates otherwise:</u>
- 13 "Commissioner." The Commissioner of Pennsylvania State
- 14 <u>Police.</u>
- 15 "Institutionalized population." Persons who are primarily
- 16 <u>ineligible</u>, unable or unlikely to participate in the labor force
- 17 while residents of institutional group quarters, including adult_
- 18 correctional facilities, juvenile facilities, skilled nursing
- 19 facilities and other institutional facilities such as mental
- 20 hospitals and in-patient hospice facilities.
- 21 <u>"Local full-time patrol services." Patrol services provided</u>
- 22 by a municipality for a period of 24 hours a day and seven days
- 23 <u>a week through the municipality's local police department</u>,
- 24 through participation in a regional police department or through
- 25 <u>a contract with other municipal or regional police departments.</u>
- 26 <u>"Local part-time patrol services." Patrol services provided</u>
- 27 by a municipality for a period of less than 24 hours a day and
- 28 less than seven days a week by a municipality through the
- 29 municipality's local police department, through participation in
- 30 <u>a regional police department or through a contract with other</u>

1	municipal or regional police departments.
2	"Patrol services." Police services provided to protect
3	public safety by maintaining order, protecting people and
4	property and enforcing motor vehicle and criminal laws through
5	routine visits through a municipality.
6	"State Police." The Pennsylvania State Police.
7	"State Police full-time patrol services." Patrol services
8	provided by the Pennsylvania State Police to a municipality for
9	a period of 24 hours a day and seven days a week in a
10	municipality that does not have local full-time patrol services.
11	"State Police part-time patrol services." Patrol services
12	provided by the Pennsylvania State Police that supplement the
13	local part-time patrol services provided in a municipality.
14	<u>§ 2503. State Police patrol services fee.</u>
15	(a) State Police full-time patrol servicesExcept for a
16	municipality that is subject to section 2505 (relating to State
17	Police patrol services agreements), each municipality that
18	receives State Police full-time patrol services shall pay the
19	fee under subsection (c) for the State Police full-time patrol
20	services provided in the previous calendar year.
21	(b) State Police part-time patrol services
22	(1) Except as provided under paragraph (2), each
23	municipality that receives State Police part-time patrol
24	services shall pay the fee under subsection (c) for State
25	Police part-time patrol services provided in the previous
26	<u>calendar year.</u>
27	(2) The following apply:
28	(i) The following municipalities shall be exempt
29	from paying the fee for service under paragraph (1):
30	(A) A municipality that is subject to section

2	(B) A municipality with a population of 1,000 or
3	less that provides local part-time patrol services
4	for at least 40 hours per week.
5	(C) A municipality with a population of more
6	than 1,000 but less than 3,500 that provides local
7	part-time patrol services for at least 80 hours per
8	week.
9	(D) A municipality with a population equal to or
10	greater than 3,500 that meets the requirement under
11	clause (C) and provides local part-time patrol
12	services for an additional 40 hours per week for each
13	2,500 in population greater than 3,500.
14	(ii) A municipality that qualifies for an exemption
15	under subparagraph (i)(D) shall not be considered to
16	provide local full-time patrol services.
17	<u>(c)</u> Fees
18	(1) The total annual fee assessed by the commissioner
19	for all municipalities subject to subsections (a) and (b)
20	shall be equal to the appropriation to the State Police from
21	the Motor License Fund during fiscal year 2016-2017 less the
22	appropriation to the State Police from the Motor License Fund
23	beginning during the calendar year during which the services
24	are provided.
25	(2) Each municipality subject to subsection (a) or (b)
26	shall be assessed a portion of the total annual fee under
27	paragraph (1) on a per capita basis, except that a
28	municipality that receives State Police part-time patrol
29	services shall pay a fee of one-third per capita of the rate
30	assessed to municipalities that receive State Police full-

2	municipality shall be based upon the most recent Federal
3	decennial census but shall not include the institutionalized
4	population.
5	(d) Determination and payment
6	(1) The commissioner shall determine whether a
7	municipality receives State Police full-time patrol services
8	or State Police part-time patrol services and shall maintain
9	a list of those municipalities. The commissioner shall make
10	the list available to municipal officials.
11	(2) The commissioner shall submit an invoice by February
12	<u>1 each year for State Police full-time patrol services or</u>
13	State Police part-time patrol services provided in the
14	preceding calendar year to each municipality determined under
15	paragraph (1). The fee for services shall be paid on a
16	quarterly basis in equal installments to the Commonwealth
17	beginning July 1.
18	(e) ApplicabilityA municipality that is classified as
19	distressed under the act of July 10, 1987 (P.L.246, No.47),
20	known as the Municipalities Financial Recovery Act, shall not be
21	required to pay the fee under this section.
22	<u>§ 2504. Reduction or elimination of fee.</u>
23	If a municipality that is paying a fee under section 2503
24	(relating to State Police patrol services fee) institutes local
25	full-time patrol services or local part-time patrol services
26	during the calendar year sufficient to cause a reduction or
27	elimination in the fee owed by the municipality, the
28	commissioner shall adjust the fee to reflect the municipality's
29	local full-time patrol services or local part-time patrol
30	services during that portion of the year.

2	(a) Contract requirement A municipality that eliminates
3	local full-time patrol services or local part-time patrol
4	services after the effective date of this chapter shall enter
5	into an agreement with the State Police for State Police full-
6	time patrol services or State Police part-time patrol services
7	on terms established by the commissioner.
8	(b) FeesThe commissioner shall establish a reasonable fee
9	and payment schedule for State Police full-time patrol services
10	or State Police part-time patrol services provided under
11	subsection (a). In setting the fee, the commissioner may
12	consider all of the following regarding a municipality:
13	(1) Population.
14	<u>(2) Square mileage.</u>
15	(3) Crime rates.
16	(4) Other factors deemed relevant by the commissioner.
17	(c) Term and renewalAn agreement under this section shall
18	have a term of one year and may be renewed for additional terms
19	in accordance with the provisions of this section.
20	(d) Local patrol servicesUpon the expiration of an
21	agreement under this section, a municipality may provide for
22	local full-time patrol services or local part-time patrol
23	services. The municipality shall provide to the commissioner

4	<u>§ 2510. Applicability.</u>
5	This chapter shall apply to the State Police full-time patrol
6	services or State Police part-time patrol services provided in
7	the calendar year beginning after the year in which this section
8	takes effect.
9	Section 2. This act shall take effect July 1, 2017, or

10 immediately, whichever is later.
