AN ACT

- Amending the act of April 14, 1972 (P.L.233, No.64), entitled "An act relating to the manufacture, sale and possession of controlled substances, other drugs, devices and cosmetics; conferring powers on the courts and the secretary and Department of Health, and a newly created Pennsylvania Drug, 5 Device and Cosmetic Board; establishing schedules of 6 controlled substances; providing penalties; requiring 7 registration of persons engaged in the drug trade and for the revocation or suspension of certain licenses and 9 registrations; and repealing an act," further providing for 10 prohibited acts and penalties. 11 12 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 13 14 Section 1. Section 13(f)(1.1) of the act of April 14, 1972 15 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, is amended to read: 16 17 Section 13. Prohibited Acts; Penalties. -- * * * 18 Any person who violates clause (12), (14) or (30) of 19 subsection (a) with respect to: * * * 20
- 21 (1.1) Phencyclidine; methamphetamine, including its salts,

- 1 isomers and salts of isomers; coca leaves and any salt,
- 2 compound, derivative or preparation of coca leaves; tianeptine
- 3 and any salt, compound, derivative or preparation of tianeptine;
- 4 any salt, compound, derivative or preparation of the preceding
- 5 which is chemically equivalent or identical with any of these
- 6 substances, except decocanized coca leaves or extracts of coca
- 7 leaves, which extracts do not contain cocaine or ecgonine; and
- 8 marihuana in a quantity in excess of one thousand (1,000)
- 9 pounds, is guilty of a felony and upon conviction thereof shall
- 10 be sentenced to imprisonment not exceeding ten years, or to pay
- 11 a fine not exceeding one hundred thousand dollars (\$100,000), or
- 12 both, or such larger amount as is sufficient to exhaust the
- 13 assets utilized in and the profits obtained from the illegal
- 14 manufacture or distribution of these substances.

- 16 Section 2. This act shall take effect in 60 days.
