A RESOLUTION

Adopting permanent rules for the House of Representatives, further providing for government oversight committees. 2 3 RESOLVED, That the Permanent Rules of the House of Representatives (2019-2020) be adopted as the Permanent Rules of the House of Representatives for the 2021-2022 session of the House of Representatives with the following amendments to the 6 heading and Rule 45(a): 7 8 [2019-2020] 2021-2022 9 GENERAL OPERATING RULES 10 OF THE HOUSE OF REPRESENTATIVES 11 12 RULE 45 (a) 13 Government Oversight Committee 14 The Government Oversight Committee shall consist of nine 15 members, five of whom shall be members of the majority party 16 appointed by the Majority Leader and four of whom shall be members of the minority party appointed by the Minority Leader. 17

- 1 The Majority Leader shall appoint the chair and secretary for
- 2 the committee. The Minority Leader shall appoint the minority
- 3 chair for the committee. A majority of the members of the
- 4 committee shall constitute a quorum.
- 5 The members of the committee shall first meet upon the call
- 6 of the chair and perfect its organization. The committee shall
- 7 have the power to promulgate rules not inconsistent with this
- 8 rule or the Rules of the House that may be necessary for the
- 9 orderly conduct of its business.
- 10 The chair of the committee shall notify all members on the
- 11 committee at least 24 hours in advance of the date, time and
- 12 place of meetings and, insofar as possible, the subjects on the
- 13 agenda. Meetings may be called from time to time by the chair of
- 14 the committee as the chair deems necessary.
- The committee shall be authorized and empowered to do all of
- 16 the following:
- 17 (1) Conduct oversight hearings to determine whether an issue
- 18 warrants an investigation under subsection (2).
- 19 (2) Conduct hearings at any place in this Commonwealth to
- 20 investigate any matter referred to the committee by the Speaker,
- 21 the Majority Leader or the Minority Leader. Referred matters
- 22 shall relate to executive agencies and administrative actions
- 23 and may not include matters which are:
- 24 (a) under the jurisdiction of the Committee on Ethics;
- 25 (b) under the jurisdiction of the Committee on
- 26 Appropriations, except matters which may incidentally include
- 27 information related to expenditures of public money; or
- 28 (c) within the scope of an adopted House resolution
- 29 authorizing and empowering a standing committee, subcommittee or
- 30 select committee to investigate any matter.

- 1 Unless in conflict with the provisions of this rule, Rule 51
- 2 shall be applicable to hearings of the committee concerning
- 3 referred matters.
- 4 [(2)] (3) Any action necessary to fulfill any assignment or
- 5 duty given to the committee by any resolution or other rule of
- 6 the House.
- 7 The committee may issue subpoenas for documents or testimony
- 8 as part of the investigation of any matter referred to the
- 9 committee. Notwithstanding any other rule of the House,
- 10 subpoenas issued under this rule shall be in the name of the
- 11 committee, shall be signed by the chair of the committee and
- 12 attested by another member of the committee who voted in favor
- 13 of either authorizing the subpoena or authorizing the chair to
- 14 issue subpoenas.
- 15 A subpoena issued by the committee may be served upon any
- 16 person and shall have the force and effect of a subpoena issued
- 17 out of the courts of this Commonwealth. Subpoenas shall be
- 18 served by the Sergeant-at-Arms of the House or other person
- 19 designated by the committee when directed to do so by the
- 20 committee. Each subpoena shall be addressed to the witness and
- 21 shall state that the proceeding is before a committee of the
- 22 House for which the witness is required to attend and testify at
- 23 a specified time and place; or to produce books, papers,
- 24 records, accounts, reports, documents and data and information
- 25 produced and stored by any electronic data processing system; or
- 26 both, as the committee may also require. All subpoenaed items
- 27 shall be maintained and returned in accordance with Rule 51.
- 28 Mileage and witness fees shall be paid by the House to the
- 29 witness in an amount prescribed by law. A person who willfully
- 30 neglects or refuses to comply with a subpoena issued by the

- 1 committee shall be subject to the penalties provided by the laws
- 2 of this Commonwealth with respect to such willful neglect or
- 3 refusal. The committee may quash or modify the subpoena if it
- 4 finds the subpoena to be overly broad or without proper purpose.
- 5 Each member of the committee shall have power to administer
- 6 oaths and affirmations to witnesses appearing before the
- 7 committee.
- 8 Upon completion of the investigation of any matter referred
- 9 to the committee, the committee shall file a final report with
- 10 the House. A final report of a referred matter shall not be
- 11 considered in the committee unless the report has been available
- 12 to committee members for at least three days before
- 13 consideration, excluding Saturdays, Sundays, and legal holidays,
- 14 unless the House is in session on those days. A report on a
- 15 referred matter shall be adopted by a majority vote of the
- 16 committee members to which the committee is entitled, present at
- 17 a committee session actually assembled and meeting as a
- 18 committee. Members of the committee may prepare in writing and
- 19 file a minority report, setting forth the reasons for their
- 20 dissent. Such committee reports shall be filed with the Chief
- 21 Clerk within five days of the meeting.
- 22 The committee shall not continue to exist after sine die
- 23 adjournment of the General Assembly. Investigation of any
- 24 referred matter before the committee that has not been concluded
- 25 or disposed of by [October 31] November 30 of the second year of
- 26 a legislative term shall cease on such date, and all documents,
- 27 reports, communications, transcripts and other materials
- 28 compiled by the committee for such matters shall be collected,
- 29 organized and submitted to the Chief Clerk under seal for
- 30 transition to the reconstituted committee consisting of members

- 1 appointed from the incoming General Assembly. These materials
- 2 shall be held in a secure manner and nothing in this rule shall
- 3 authorize the Chief Clerk or any other person to view such
- 4 materials. Within 30 days following the reconstitution of the
- 5 committee in the next succeeding legislative term, the committee
- 6 shall review such materials and determine whether or not to
- 7 proceed with a referred matter investigated by the former
- 8 committee.
