A RESOLUTION

1 2	Designating the week of September 27 through October 2, 2020, as "Juvenile Services Providers Week" in Pennsylvania.
3	WHEREAS, Pennsylvania's array of public and private service
4	providers has continued to evolve in response to juvenile
5	justice system reform efforts by improving the quality of
6	service delivery and simultaneously striving to ensure the
7	protection of our communities; and
8	WHEREAS, The Pennsylvania Partnership for Juvenile Services
9	(PPJS), an association of Pennsylvania service providers, was
10	originally established in 1978 and is celebrating 42 years as a
11	juvenile justice service provider; and
12	WHEREAS, Pennsylvania service providers have adapted to
13	serving low-risk to moderate-risk youths within the community
14	and moderate-risk to high-risk youths in residential programs;
15	and
16	WHEREAS, Pennsylvania service providers offer uniquely

17 designed programs to all 67 counties of this Commonwealth to

address the individualized needs of specific populations,
including secure detention, secure treatment, institutional
facilities, group homes, foster homes and community-based and
in-home family-based programming; and

5 WHEREAS, The members of PPJS, adhering to the Balanced and Restorative Justice Model, contribute to public safety by 6 7 providing a stable environment for at-risk youths, providing 8 education and programming and ensuring sufficient opportunities for growth and development of Pennsylvania's youth; and 9 10 WHEREAS, The members PPJS also ensure every child's health and well-being by providing competency development, self-11 12 discipline and stabilization through comprehensive physical and 13 behavioral health evaluations as well as community involvement; 14 and

15 WHEREAS, Thousands of men and women are dedicated to ensuring 16 the proper care and supervision of youths through the 17 application of evidence-informed practices and trauma-informed 18 approaches designed to positively impact youth according to 19 their developmental needs; and

20 WHEREAS, Youth care worker members of the PPJS stand ready to 21 respond to youths who display an array of unresolved mental 22 health, behavioral, educational, emotional and intellectual 23 issues; and

24 WHEREAS, PPJS acts as a key resource for these service 25 providers offering education, representation and support for the 26 important services they provide for the Commonwealth's youths 27 and communities; and

28 WHEREAS, Pennsylvania's juvenile justice service providers in 29 coordination with PPJS, merit a week of recognition for their 30 unending services aimed at protecting our communities and
