A RESOLUTION

- Designating October 30, 2018, as "Violent Crime Survivors'
 Assistance and Grief Support Day" in Pennsylvania.
- 3 WHEREAS, Violent crimes impact every community in this
- 4 Commonwealth, with more than 40,000 offenses committed in 2016;
- 5 and
- 6 WHEREAS, Nearly half of these violent crimes were committed
- 7 in the five-county southeastern region of this Commonwealth,
- 8 including more than 15,000 in Philadelphia and more than 2,100
- 9 in Delaware County; and
- 10 WHEREAS, Violent crimes leave a trail of victims and
- 11 survivors who need and deserve support services provided with
- 12 compassion and accountability as they cope and recover; and
- 13 WHEREAS, The victims' movement began slowly after World War
- 14 II, fueled by the recognition of the evils of genocide
- 15 perpetrated by Nazi Germany; and
- 16 WHEREAS, The movement gained momentum in the 1970s and 1980s

- 1 with rising social consciousness and through the passage of
- 2 Federal laws, including the Victim and Witness Protection Act of
- 3 1982, the Victims' Rights and Restitution Act of 1990 and the
- 4 Violence Against Women Act of 1994; and
- 5 WHEREAS, The Commonwealth recognizes victims' rights to
- 6 receive advocacy and notification of significant actions in
- 7 criminal proceedings and their rights to restitution,
- 8 compensation and prompt return of seized property; and
- 9 WHEREAS, Crime victims who do not receive support services
- 10 are more likely to develop a substance abuse problem, experience
- 11 depression or post-traumatic stress disorder, become
- 12 underemployed or unemployed and have higher health care costs
- 13 over their lifetime; and
- 14 WHEREAS, An estimated 370,000 victims have received support
- 15 services through the Pennsylvania Commission on Crime and
- 16 Delinquency's Office of Victims' Services; and
- 17 WHEREAS, The Centers for Disease Control and Prevention
- 18 recognizes violence as a public health issue that can be reduced
- 19 with proven prevention programs addressing social, emotional,
- 20 behavioral and family dynamics; and
- 21 WHEREAS, Municipal support for reducing violence and
- 22 providing services to survivors is imperative for building
- 23 strong links between the community, law enforcement, support
- 24 groups and other entities; and
- 25 WHEREAS, It is fitting that we honor the bravery of crime
- 26 survivors and the dedication of those providing vital help to
- 27 survivors across this Commonwealth; and
- 28 WHEREAS, The Commonwealth must raise awareness of the
- 29 resources and support services available to all victims and
- 30 survivors of violent crimes; therefore be it

- 2 30, 2018, as "Violent Crime Survivors' Assistance and Grief
- 3 Support Day" in Pennsylvania.
