A RESOLUTION

- Condemning President Joseph Biden's failure to heed the advice 2 of military and intelligence advisors about the speed and

- nature of the Taliban offensive, leading to a disorganized, chaotic and abrupt evacuation of United States personnel and
- Afghan allies. 5
- 6 WHEREAS, Despite increasing Taliban violence in the first
- 7 three months of 2021 and intelligence that the Taliban and al-
- Qaida were maintaining close ties, on April 14, 2021, President 8
- Biden announced a full United States troop withdrawal from
- 10 Afghanistan by September 11, 2021; and
- 11 WHEREAS, In President Biden's April 14, 2021, announcement of
- full United States troop withdrawal, he stated, "We will not 12
- conduct a hasty rush to the exit" and "We'll do it we'll do it 13
- 14 responsibly, deliberately, and safely," flatly denying the
- 15 assessments from his own intelligence community about prospects
- 16 for the fall of the government in Kabul; and
- WHEREAS, On July 6, 2021, the United States military withdrew 17
- from Bagram Air Base, Afghanistan, reportedly without notifying 18

- 1 the base's new Afghan commander; and
- 2 WHEREAS, On July 8, 2021, President Biden said that "There's
- 3 going to be no circumstance where you see people being lifted
- 4 off the roof of a embassy in the of the United States from
- 5 Afghanistan," adding "the likelihood there's going to be the
- 6 Taliban overrunning everything and owning the whole country is
- 7 highly unlikely" and moved up the September 11, 2021, withdrawal
- 8 date to another arbitrary date of August 31, 2021; and
- 9 WHEREAS, On July 12, 2021, President Biden ordered 4-star
- 10 General Austin Miller, Commander of NATO's Resolute Support
- 11 Mission and United States Forces-Afghanistan, to relinquish his
- 12 position and depart Afghanistan, leaving the remaining United
- 13 States presence without a seasoned leader in the face of a
- 14 growing Taliban offensive; and
- WHEREAS, On August 6, 2021, the first provincial capital,
- 16 Zaranj, fell to the Taliban since the signing of the United
- 17 States-Taliban agreement, leading to a violent onslaught of
- 18 offensives throughout other Afghan provinces; and
- 19 WHEREAS, On August 15, 2021, the United States Embassy in
- 20 Kabul was evacuated and Taliban fighters soon stood outside
- 21 chanting "death to America"; and
- 22 WHEREAS, As of August 23, 2021, the Department of State and
- 23 the Department of Defense were unable to provide the number of
- 24 United States citizens and lawful permanent residents (LPRs)
- 25 remaining in Afghanistan, including the status of Mark Frerichs,
- 26 who is held hostage, an estimate of how long it will take to
- 27 evacuate this number of citizens and LPRs and what efforts are
- 28 being made to secure their return to the United States; and
- 29 WHEREAS, The Biden administration received countless letters,
- 30 calls and oversight questions from bipartisan members of

- 1 Congress over the last seven months on plans for the withdrawal
- 2 that received minimal response; therefore be it
- RESOLVED, That the House of Representatives of the
- 4 Commonwealth of Pennsylvania condemn:
- 5 (1) President Joseph Biden's failure to heed the advice
- of military and intelligence advisors about the speed and
- 7 nature of the Taliban offensive, leading to a disorganized,
- 8 chaotic and abrupt evacuation of United States personnel and
- 9 Afghan allies.
- 10 (2) President Biden's inability to present a coherent
- 11 plan to prevent a Taliban takeover or prepare for the long-
- 12 term counter-terrorism effects of a withdrawal, to
- effectively plan for the evacuation of United States citizens
- or to adequately respond to concerns from Congress about the
- need to rapidly take steps to evacuate our Afghan allies
- following his announcement of full United States troop
- 17 withdrawal.
- 18 (3) The damage done to United States credibility,
- 19 partnerships and national security by President Biden's
- abandonment of our Afghan allies, the failure to consult with
- 21 our NATO partners and the creation of a vacuum for terrorist
- 22 networks and other United States adversaries to thrive in;
- 23 and be it further
- 24 RESOLVED, That the House of Representatives of the
- 25 Commonwealth of Pennsylvania call on the President to conduct a
- 26 multiagency accounting of United States military equipment and
- 27 other resources left behind in Afghanistan, now in the hands of
- 28 the Taliban, or other groups, and immediately present a clear
- 29 plan to Congress of how he intends to fill the intelligence gaps
- 30 created by this chaotic withdrawal; and be it further

- 1 RESOLVED, That the House of Representatives of the
- 2 Commonwealth of Pennsylvania call on President Biden to commit
- 3 to ensuring the full evacuation of any remaining United States
- 4 citizens and at-risk Afghans and allies from Afghanistan and to
- 5 utilize all available and necessary resources to achieve this
- 6 mission.
